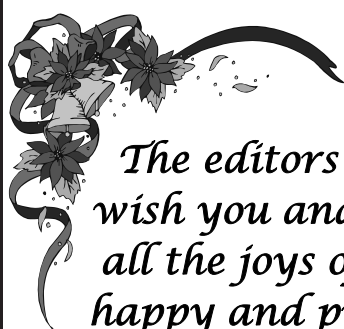

## **Why Supervising Kids and Dogs Doesn't Work**

It's sound advice given frequently: Supervise your dogs and kids while they are together. Breeders warn parents, "Don't leave the dog alone with children, no matter how friendly the breed." Veterinarians advise, "Never leave a dog and a child in the same room together." Dog trainers explain, "All dogs can bite so supervise your dog when you have children over." Everyone knows the drill. So why doesn't it work? Why are there an estimated 800,000 Americans seeking medical attention for dog bites each year, with over half of these injuries to children ages 5-9?

The bites are not a result of negligent parents leaving Fido to care for the baby while mom does household chores, oblivious to the needs of her children. In fact, I've consulted on hundreds of dog bite cases and 95% of the time the parent was standing within 3 feet of the child watching both child and dog when the child was bitten. Parents are supervising. **The problem is not lack of supervision. The problem is no one has taught parents what they should be watching.**

Parents generally have not received any education on what constitutes good dog body language and what constitutes an emergency between the dog and the child. Parents generally have no understanding of the predictable series of canine body cues that would indicate a dog might bite. And complicating matters further, most parents get confused by the good intentions of the child and fail to see when a dog is exhibiting signs of stress. The good news is all of this is easy to learn! We can all get better at this.

Here is a simple list to help you improve your supervision skills:

**Watch for loose canine body language.** Good dog body language is loose, relaxed, and wiggly. Look for curves in your dog's body when he is around a child. Stiffening and freezing in a dog are not good. If you see your dog tighten his body, or if he moves from panting to holding his breath (he stops panting), you should intervene. These are early signs that your dog is not comfortable.

**Watch for inappropriate human behavior.** Intervene if your child climbs on or attempts to ride your dog. Intervene if your child pulls the ears, yanks the tail, lifts the jowls or otherwise pokes and prods the dog. Don't marvel that your dog has the patience of Job if he is willing to tolerate these antics. And please don't videotape it for YouTube! Be thankful your dog has good bite inhibition and intervene before it's too late.

**Watch for these three really easy to see stress signals in your dog.** All of them indicate you should intervene and separate the child and dog:

Yawning outside the context of waking up

Half-moon eye – this means you can see the whites of your outer edges of your dog's eyes.

Lip licking outside the context of eating food

**Watch for avoidance behaviors.** If your dog moves away from a child, intervene to prevent the child from following the dog. A dog that chooses to move away is making a great choice. He's saying, "I don't really want to be bothered, so I'll go away." However, when you fail to support his great choice and allow your child to continue to follow him, it's likely the dog's next choice will be, "Since I can't get away, I'll growl or snap at this kid to get the child to move away." Please don't cause your dog to make that choice.

**Listen for growling.** I can't believe how many times I've heard parents say, "Oh, he growled all the time but we never thought he would bite." Dog behavior, including aggression, is on a continuum. For dogs, growling is an early warning sign of aggression. Heed it. If growling doesn't work, the dog may escalate to snapping or biting. Growling is a clue that you should intervene between the dog and the child.

To pet owners, particularly those who also have children, thank you for supervising your dog! As a dog trainer and mother of two, I know that juggling kids and dogs is no easy feat. It takes patience, understanding, and a great deal of supervision. I hope these tips will help you get better at supervising.

## Kimberton Obedience Report

Seven Kerry Blue Terriers participated in the Montgomery All-Terrier Agility Cluster (MATAC) trials held in Kimberton, PA, on October 2-4. This year we had Kerries entered in every level -- Novice, Open, Excellent, Preferred and Masters. Sadly, the overall entries for MATAC this year were significantly lower than any previous trial at this site. The biggest reason for the drop in entries is the weather factor since this is an outdoor trial and more often than not it's cold and rainy. Wouldn't you



know that this year every day saw sunny skies and temperatures in the mid-80's. No one wanted to complain about the heat because we had NO RAIN!!! The MATAC trial has always been one of my favorite trials of the year. Competing with nothing but Terriers and the camaraderie among fellow Terrier exhibitors from all over makes this especially fun and unique.



Our Kerries did very well at the trial. France Godbout's young girl, Tiara, competed in Novice Standard and Novice Jumpers all 4 days, earning 2 jumpers and 2 standard legs towards her

title, including 3 First Place and 1 Second Place ribbons. Tiara also earned the USKBTC supported High In Trial awards offered for the highest scoring Novice/Open/Excellent level dog for the week! Carol Wert showed Maeve for 3 of the 4 days, qualifying in Excellent Jumpers on Friday. Carol also participated in Obedience on Wednesday at a different site. Barbara Fleischmann and her girl Dazzle came for Thursday and Friday. Dazzle earned her Open Jumpers title on Thursday, which was also her birthday! Earning her title allowed Dazzle to "move up" and compete at the Excellent level in Jumpers on Friday where she had a perfect qualifying score in her Standard run. Joy Ellwanger and Athena showed in Excellent Preferred on Tuesday through Thursday. The Preferred level allows dogs to compete at a lower jump height with extra course time, and is a good way to let our older dogs continue to play the game. Athena is an experienced competitor and had a good week,



qualifying in 4 out of 6 Standard and Jumpers runs, all First Place! Athena took home the USKBTC HIT awards for the Preferred Level dog. The Masters level had three dogs competing this year. JudiJo Ricketts

showed JennyJo and Jaymo on Tuesday only, but neither dog qualified. I showed my boy Topper on Tuesday through Thursday. He had some very nice runs with a QQ and 2 First Places on Tuesday. I scratched his runs on Wednesday after a scary tumble off the dogwalk in the morning, but after having him massaged and checked out he ran on Thursday earning a QQ with First Place in Standard and Second Place in Jumpers. Topper took home the high scoring Masters level awards offered by the club.

Next October in 2014 the trials will be held indoors on soccer turf at In The Net in Palmyra, PA. The participating clubs and coordinators recently made the decision that the move to an indoor site was necessary to draw the entries

## Cold Weather Canine Care Tips

A dog's need for food, shelter and loving care increases during the cold winter months. Keep your dog safe and warm by following these guidelines.

- ◆ Dogs can get frostbite or hypothermia when temperatures drop. Don't leave your dog outside in the cold for long periods of time. Provide a covered shelter, such as a doghouse or kennel, for the times the dog is out of doors.
- ◆ When your dog is inside, keep him warm, dry and away from drafts. Tiles and uncarpeted floors may become very cold, so put down blankets or pads for him to lie on.
- ◆ Keep your dog a safe distance from supplemental heat sources such as portable heaters and fireplaces, which can cause severe burns. Place screens around fireplaces.
- ◆ Don't leave your dog alone in a car on cold days.
- ◆ Feed your dog additional calories, particularly if it spends a lot of time outdoors or if it is a working dog. The extra calories are necessary because it takes more energy in the winter to regulate body temperature.
- ◆ Provide plenty of fresh water at all times. Dogs are just as likely to get dehydrated in winter as in summer. Snow is not a good substitute for water.
- ◆ Groom your dog regularly. Your dog needs a well-groomed coat to keep properly insulated. If you have a short-haired dog, consider a sweater or coat. If your dog is long-haired, clip the hair around its paws to ease snow removal.
- ◆ Dry your dog with a towel or blow-dryer if it gets wet from rain or snow. Clean snow and ice from its paws to prevent cuts and cracked pads. A little petroleum jelly may help soften and soothe paw pads.
- ◆ Be extra careful when walking or playing with your dog near frozen lakes, rivers or ponds. Your dog could slip or jump in and be seriously injured.
- ◆ Rock salt, used to melt ice on sidewalks, can irritate paw pads. Rinse and dry your dog's feet after a walk.
- ◆ Watch out for spilled antifreeze on driveways. Antifreeze smells and tastes good to dogs, but it can be lethal.
- ◆ Dogs, like humans, seem to be more susceptible to illness in the winter. Take your dog to the veterinarian if you notice any signs of illness.

## 2013 Terriers Only Performance Summit (TOPS)

TOPS is an event, put on since 2008 by the Rocky Mountain Terrier Club, that offers AKC agility, obedience, and rally trials, in one location, to dogs in the Terrier Group. The intent was to offer an all-Terrier performance event similar to what is done at Kimberton, PA each year, but in a location that was more centrally located. The first TOPS shows were held in Greeley, Colorado in 2008 and 2009, after which RMTAC decided to offer it only every other year. This year's show, in Lakewood, Colorado was the fourth TOPS, with the next one being planned for 2015.

This year's TOPS consisted of an all-breed agility trial on Friday, followed by Terrier-only agility, obedience, and rally trials on Saturday and Sunday. Five Kerries participated: Remington, owned by Lisa Frankland, and competing in agility, obedience, and rally; Grace, owned by Ann Chinnock, competing in obedience and rally; Riley, owned by Betty Richardson, competing in agility and rally; Meghan, owned by Judy Wick, competing in agility; and Derby, owned by Karen Loken, competing in agility and obedience.

There were many qualifying scores as well as several accolades among the Kerries. In obedience, Remington and Lisa Frankland earned their first two UDX legs and were High Combined on Sunday. In rally, Grace and Ann Chinnock earned two RAE legs and tied for Saturday's Rally High Combined with a first and second place in very large and very challenging Advanced and Excellent rally classes, while also on Saturday both Remington and Lisa Frankland and Riley and Betty Richardson won their classes while finishing their rally novice and rally excellent titles, respectively. And all of the Kerries, as well as their owners had a great time!

An earthdog trial is normally held on the Monday after TOPS; however, this event is limited to the smaller terrier breeds as well as Dachshunds. Hopefully, the 2015 TOPS events will include Barn Hunt, which Kerries can do, and do very well!

## 2013 Versatility Award Recipients

The USKBTC's Versatility Award program was started in 2004 to recognize members' Kerry Blue Terriers who have exemplified the breed's reputation as "a canine jack-of-all-trades and a master at most" by earning titles in two or more eligible areas. There are currently seven achievement levels that are awarded for attaining titles in each of seven different areas: conformation, obedience, agility, rally, tracking, herding, and "earthdog" (Kerries aren't eligible for AKC or AWTA earthdog titles, so the AWTA's Hunting Certificate or the new Barn Hunt titles are accepted for this category). In addition, we added a "wildcard" category a few years ago, where an approved title from an event that doesn't fit into any of the regular categories can be substituted for one achievement level. Flyball, AKC coursing ability, AKC Therapy Dog (THD), canine nosework, and UKC weight pulling are all examples of titles that can be used towards the wildcard category.

With the addition of several new events and AKC titles and certificates in the past few years, there has been some confusion about which of these satisfy the requirements for a Versatility Award level, and why. First of all, I want to emphasize that the primary intent of the Versatility Awards has always been to encourage Kerry owners to get out there and *try* different events with their dogs. So the minimum title requirement in each category is traditionally the regular novice-level title (not pre-novice or optional/non-regular)—e.g., CD for obedience, RN for Rally, RATN for earthdog, etc. These titles all require multiple passing scores under different judges (not evaluators or volunteers) at sanctioned trials/tests/shows. So the CGC doesn't count towards the Versatility Award since it is a one-time test conducted by an evaluator, not a licensed judge. The new AKC Herding Instinct (HI) certificate does not count for similar reasons. However, regardless of whether a title or certificate counts towards a Versatility Award level, it is still an accomplishment to be proud of and will be included as part of the dog's name on the award certificate. The title requirements for each category are included in the Versatility Award rules and on the award application that is available in *Blueprints* and on the USKBTC website.

## ***A Word from Charitable Funds...***

As many of you know the US Kerry Blue Charitable Fund was established in 2002. Its purpose was to serve the Kerry Blue Terrier in four important areas:

- 1) Rescue Fund** – this fund supports grants used to provide Kerry Blue Terrier rescue services.
- 2) Health and Genetics Fund** - this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier.

## **It All Started With My Mother...**

It all started with my mother. Spoken like a true psychologist, but, in this case, it is accurate. My mother entered an assisted living facility when my first KBT, Tess, was elderly. Since my mother and Tess had a wonderful relationship, I brought Tess to the facility every time I visited. Not only did Tess bring joy to my mother, but many of the other residents asked to play with and pet her. Many started talking about their own former pets, sharing memories about their cats and dogs. Seeing how much pleasure Tess was able to engender, I vowed to myself that if I ever got another KBT I would pursue having the dog registered as a therapy dog.

My mother died before Tess, but I didn't forget my vow. When Moxie (Paxon's She's Got Style) came into my life, I knew that I would work with her to become a therapy team. Moxie was registered as a therapy dog by Therapy Dogs International and as a Reading Educational Assistance Dog by Intermountain Therapy Group when she was one and a half years old. I am a N.Y.S. certified Psychologist who has worked with children with special needs for over twenty years. Ever since puppyhood, Moxie showed an interest in children and a love of toys and games. I wanted to find a setting that would combine both of our talents so that we could both have fun while helping others; I thought that a special education school would be ideal. I was fortunate enough to find a school that believed in animal assisted therapy and Moxie and I began to visit the Cooke Center Academy in January, 2011. Cooke Center Academy serves a high school aged population and all the students have neurological, educational, developmental, and often physical disabilities.

I knew that working with a dog would be a positive experience for the individual students who worked with Moxie, but I was unprepared for the impact that Moxie had on all the students and staff. Moxie became a school 'mascot' with cries of 'hello, Moxie' resounding in the school halls every time we walked in. She became so popular with the students and such an important part of their therapies, that her time at school increased and I felt that too much was being asked of her. I wanted to get her a helper so I searched for a KBT puppy that would be a good match for the job and Flint (Charisma's Light My Fire) became part of my and the school's family. Flint began coming to school with Moxie and me when he was four months old. The staff and students welcomed him with open arms and became his teachers - a role they embraced. For the students, it allowed them to be the 'capable' ones who could show him what to do. Moxie rose to the occasion and was the perfect role model.

Moxie and Flint have distinct and different personalities, but some of their interests overlap. Moxie is reserved, cautious, friendly, but particular about whom she befriends. Flint is outgoing, daring, and always ready

for a challenge. They both are curious and love to learn new games which makes it easy to train them. Knowing a dog's personality is important when deciding which therapeutic activities he/she would enjoy.

The dogs and I are an adjunct to the therapies that the students are receiving. Therefore, I consulted with the primary specialists that were involved in the care of the students and we jointly developed treatment goals that included how working with Moxie and Flint could encourage growth.. We are part of ongoing occupational therapy and counseling sessions and the goals are multifaceted, but developing and deepening a trusting relationship with a dog is an overriding goal. Students with varied diagnoses may need to acquire the same set of skills so goals are set based upon the specific skills that the student needs to master rather than on the diagnosis. Furthermore, the same activity can address more than one skill. Having two dogs available, allowed us to pick which one would most meet a student's need. Sometimes, the student chose which dog to be with based upon his/her emotional reaction. In general, adding the dogs to an activity acts as a motivator and turns a 'job' into play.

All of Moxie's and Flint's training uses shaping of behavior techniques and positive reinforcement. We collaborate with dog trainer Lois Platt of Real Life Obedience who takes my ideas for games, teaches me how to implement them with the dogs, expands on them to make them better, and offers ideas of her own. All the games require interaction between a child and a dog. Moxie has a repertoire of games that Flint is now learning. Some of our favorite games are "puzzle," "alphabet," "piano," "basketball" and "roll roll." The dogs are cued to the game by these titles and, of course, by the sight of the toy. For "puzzle," Moxie has learned how to take out and put back puzzle pieces from puzzles that are usually used by toddlers; they have large wooden knobs that allow Moxie to grab them in her mouth. Students take turns with Moxie to pull out and put back the puzzle pieces; on the cue, "Moxie's turn," she can remove a piece and give it to the student and she can place the piece on the puzzle board when told to "place." Not only are there smiles on everyone's face, but the student is learning how to take turns, wait for a turn, and sequence actions. We use a pegboard with upper and lower case letters for the "alphabet" game and both dogs have learned to retrieve a rubber ring and

randomly place it on a peg. In this game, the student throws the ring and when Flint places it on a letter, the student has to say the letter's name and sound. It's a fun way to reinforce phonemic awareness for children who are having trouble learning to read. Mozart has nothing over Moxie; she has learned to "touch" a keyboard with her paw to make beautiful music and we invite the children to play a duet with her. Most children are familiar



with the game of "basketball" and have thrown balls into hoops. Using a basketball hoop that is low to the ground, Moxie and Flint can put the ball into the hoop. Many skills can be

addressed with this game, such as, eye hand coordination, taking turns, dealing with frustration when the ball does not go in the hoop, and sportsmanship if the child becomes competitive with the dogs. As a puppy, Moxie began using her nose to hit a rolling ball back to me. Using her style of play, I developed a game, calling it "roll roll," in which Moxie is put on a "down, stay" and the students roll a medium size rubber ball to her which she 'bats' back with her nose. The trick is that the ball has to come near her nose because she remains in the "down, stay" position; this encourages the student to aim for her nose which requires good eye hand coordination. Flint did not have this same behavior as a puppy so he needed more shaping of behavior in order to master this game.

Both of my dogs are playful and curious and can become excited when they see some of their favorite toys being taken out in the session. I have worked hard to have some confidence that the dogs are in good enough control even when excited to play safely with the children. For example, they always are on a "sit, stay" when the game is taken out. They are invited to join the game with a "take it" or a "let's play" cue. Waving a toy or a ball in front of them does not mean that they can play. They know that when I touch my wristwatch and say "time to stop" the game is ended. All of the children are taught these cues so that they can initiate and stop play. I have found that not only do these cues make play safer, but they also give the children a sense of mastery and control which makes them feel proud of their ability to 'train' the dog.

Rally in particular is a wonderful tool when working with children who have executive functioning or motor planning issues. Children with attentional weaknesses benefit because learning how to accomplish the individual rally maneuvers and then follow the signs

around a course requires focused attention, the ability to plan and organize oneself for a task, and the capacity to stay with a task despite frustrations over making mistakes. Those with motor planning problems can practice sequencing, directionality, and body position in space.

While many students at Cooke Center Academy begin their work with Moxie and Flint having already developed positive feelings towards dogs, there are others who are afraid of, or uncomfortable, around dogs. Some students are so afraid of dogs that they become a hazard to their classmates if they pass a dog on the street while on a class trip; they may scream, begin to run away, or freeze and refuse to move until the dog has passed. For the students who are less fearful, seeing the dogs walk through the school and watching their peers pet them acts as a desensitization experience. However, for the students who are terrified of dogs, we have established a formal desensitization program in which the student starts out with the least scary interaction with the dogs and moves towards goals of interacting with the dogs. One sixteen year old student could not tolerate being in the same room as Moxie so he started the program by watching videos of Moxie doing various activities. Over the course of a year, he felt so proud of himself because he was able to walk with Moxie, play ball with her, and even pet her for a brief few seconds. This was the first time that he had ever touched an animal! When Flint arrived, this student was cautious around him, not trusting him as much as he trusted Moxie because of the puppy's more unpredictable behaviors. Moxie always remained his favorite, but his anxiety around Flint and strange dogs on the street was noticeably improved.

Sometimes, it's impossible to predict what might be therapeutic for a particular person. Flint was quite small when he first started visiting school and I would often hold him in my arms as we walked through the halls. One student in particular was terrified of dogs and although he had gotten used to Moxie walking through school, he always walked around her in a wide arc and often asked for me to



move her away from him so he could pass by. One day, while I was holding Flint in my arms as I was waiting for another student, this boy approached me and asked if he could touch Flint. I said, "Of course," hiding my surprise. He patted Flint and all the staff who witnessed this heaped praise upon him for being so brave. We talked about how soft Flint felt and he was encouraged to pet

him again. Tentatively, he did so and as all the surrounding staff praised him again, a big smile broke out on his face. We repeated this many times, telling him to show many staff how brave he was. It might be that Flint's smaller size and his being in my arms allowed this student to feel that the dog was more contained, less unpredictable and, therefore, less of a threat because he followed this petting session with a request that I hold Moxie in my arms. After this, we began working weekly with this student and even reached the point of his including Moxie in his sessions and kicking the ball to her.

Establishing an emotional relationship with a dog can be a life changing experience for children who are on the autistic spectrum. One such student was new to Cooke Center academy and was having trouble making friends because his language was idiosyncratic; he made up words and repeated random phrases. He loved dogs so it was thought that playing with Moxie would ease his transition into the new environment, but he had to learn that if he wanted to communicate with Moxie, he had to use the words that she knew and not the words that he preferred. Also, he was told that when he was with Moxie, he needed to concentrate on her and only talk about what he was doing with her. In this way, his ability to stay on topic and use communicative language was encouraged. By participating in a group that centered around playing with the dogs, he immediately had something in common with the

other students. Another student's empathy for animals increased as he developed and deepened his relationship with the dogs. Initially, during his walks with Moxie he liked to seek out and chase flocks of pigeons and he even asked if Moxie could chase them with him. I told him that I would not allow her to do that because pigeons had feelings too, but that I wouldn't stop him from chasing them. Without any other discussions, over the course of a year of working with Moxie, he progressed from chasing pigeons, to asking me for crackers to feed them, to buying seeds for them to eat.

Working with Moxie and Flint and the students at Cooke Center Academy has been a privilege; the dogs have enriched the students' lives as they have enriched the dogs' lives.

## ***Disaster!***

In the Summer 2013 issue of BLUEPRINTS, Janie MacBryde, the Editor, provided tips for disaster survival. In the last year numerous members of the US Kerry Blue Terrier Club experienced disasters which directly affected their lives. I thought it would be interesting to learn how they prepared for the disaster, whether it was a hurricane, snowstorm, tornado or fire, which affected their lives. In his commentary, **“A Few Words from John,”** Club President, John Garahan, also addresses this subject. I spoke to one of our newest members, Paula Fox, and to Lisa Kunze, Gene Possidento and Carol Kearney about their recent experiences with natural disasters.

Those of us who live in the Midwest have learned to respect the cloud formations we see in the skies between April and late June. A green ominous sky is likely indicative of the threat of turbulent weather and when you see that wall cloud and all goes silent, you know something is eminent. In the Midwest, and especially in OK, where Paula Fox lives, it has been said that in earlier times, Indians warned their people NOT to settle in the land of the Angry Wind Gods.

Paula lived in Moore, OK, and her house was destroyed by the tornado that went through her community on May 20, 2013. Paula was at home that afternoon when the eye of the monster F-5 tornado ripped through her 45 acre farm and ranch. When Paula realized that she was in the path of the storm, she leashed her three Kerrys and headed to her storm cellar located below the floor in the den of the home. Paula told me that her son and family came just minutes before the half mile wide funnel hit. They heard rotating debris from trees and barns slam into the house as they **went down** the cellar steps. During the storm, her son and two other men in the cellar fought hard to hold onto the locked and already-bowing door at the bottom of the steps as the air was literally being sucked out of the cellar by the storm, and trying to pull everyone out with it. As the noise from the tornado subsided, their screams turned into cries. Paula, her family, her dogs, and others in the cellar survived. They were thankful to be alive and knew that the storm shelter was in place.....for precisely this reason.

In the event of a tornado, as an Oklahoman, Paula knew it was essential to have a disaster plan. The best possible option for survival is a storm cellar stocked with specific supplies to last for several days. Rather taking the risk of becoming disoriented at a time when it is essential to remain calm, a well thought-out plan engages survival instincts when action is needed. Most importantly, it saves lives! Her recommendations for already in the shelter before an emergency include a ready-to-go duffle bag, ID, insurance cards and any medications that you may need. During the storm season, keep a first aid kit, a few toiletries, a tooth brush & tooth paste, a washcloth or a roll of paper towels in the bag or in plastic containers in the shelter before they are needed. It is important to have a change of comfortable season appropriate clothes, and, especially, to have protective boots or tennis shoes. Rain coats, leather work gloves or gardening gloves help protect from shards of glass, splintered tree limbs, sharp metal, nails and stinging insulation which you may find after a storm. Other essential items include a case or two of bottled water, pop-top cans of food, plastic spoons, flashlights w/red emergency flasher, weather radio, batteries, and fully charged cell phones with emergency & family phone numbers. Be sure to have crates for all pets already in the shelter. If you have livestock or horses, an antibiotic spray or solution for lacerations, splints for broken bones, a box of towels or clean rags for bandaging & heavy-duty scissors to cut the towels are essential. Of additional use are tools like tree limb loppers and wire cutters; both can be invaluable for saving the lives of animals. In a limited space, choose fewer items that will best fit your situation and current needs.

As a Licensed Marriage and Family Therapist, Paula helps her clients deal with grief. When we spoke in August at a dog show, Paula was still visibly shaken talking about her experience and related to me that she KNOWS the stages of grief, but found it very hard to go through them herself. Six months after the storm, she still finds herself going through “the process” and asking herself those “Why?” questions. After the storm, Paula and her husband had moved “into town” and are still in the arduous and painful process to rebuild their lives.

As we know, both Hurricane Sandy and a monster snowstorm blanketed the New York area within the last year. Lisa Kunze is a Long Island resident and related that she and her family stayed in their home during both storms and were lucky that, after the hurricane, their home lost power only briefly. Lisa’s husband works for the power company so she was alone after the storm while her husband helped others. She spoke of preparedness being essential when ex-

pecting a storm. She and her family pay attention to the weather forecasts and do not wait until the last minute to stock up on essentials such as gas for the car or cans of gas for the generator. She also suggested that a full propane tank for the grill or camp stove provides a means to cook. She and her family have a generator which is capable of providing power for a refrigerator, a wall air conditioner, several lights and a satellite system should they lose power.

In case of evacuation, copies of important papers are on an electronic device such as a thumb drive, tablet or smartphone. Included among those documents are information and photographs of her dogs in case they become lost or separated. Additional bowls, leashes, beds, medications (human and four-legged) and crates are available. She recommends a month supply of food for our fur kids and at least a week's supply of food for us. Stocking the freezer/refrigerator is not a good idea, especially since the investment may be lost in a power outage. An essential part of her disaster preparation is flashlights and batteries, ....“you can never have too few. The new LED lights are very battery friendly.” Plenty of water is essential to humans and our fur kids, so have it on hand.

Gene Possidento lives north of New York City and had this recommendation: If your power goes out and you have a gas stove....cook!!! That's what he did several years ago during the aftermath of an ice storm and power outage. The heat from the stove/oven provided warmth and it gave him something to do! There was no need for the refrigerator/freezer....just set what you cooked outside and it was kept cold. After that storm, Gene bought a generator! However, after the hurricane in October of 2012 and the snow storm of 2013, Gene realized he needed more and is remodeling his home to install gas fireplaces for heat in several rooms. “As far as the dogs, they never missed a beat during either the hurricane or the snow storm.” Typical, isn't it???

Carol Kearney had this to say: “Let's just say now we are more prepared! We have lost power for brief periods of time many times in this area, so we always have bottled water, flashlights, candles, and batteries on hand. This last time was different. We lost electricity for over a week and, for us, that also meant NO WATER, since we have a well and electric is needed to get water up from the well. Having no running water was the worst!!! No heat and electricity for the stove and lights was easier to deal with. We have a fireplace on the first floor and a wood stove on the second floor, so we had heat and cooked on the wood stove. The supply of bottled water ran out in our area, but we had enough on hand. From time to time, Bill used our small "dog show" generator to keep the refrigerator going. We have since purchased a very large "whole house" generator and are installing a transfer switch which, when engaged, starts the generator that will be able to supply the house with enough electricity for everything we need.

You notice that I have not mentioned the dogs. That is because they never skipped a beat. I am not sure they knew there was a problem. In fact, I think they loved the idea of having the warm wood stove upstairs, since they all found a spot around the stove that they liked. “

Thank you to Paula, Lisa, Gene and Carol for sharing their experiences. Now, Kerry folks.....is your plan in place??

THE UNITED STATES KERRY BLUE TERRIER CLUB  
CODE OF ETHICS

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

I. RESPONSIBILITIES AS A MEMBER

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.



- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

## II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

## III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

## IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
