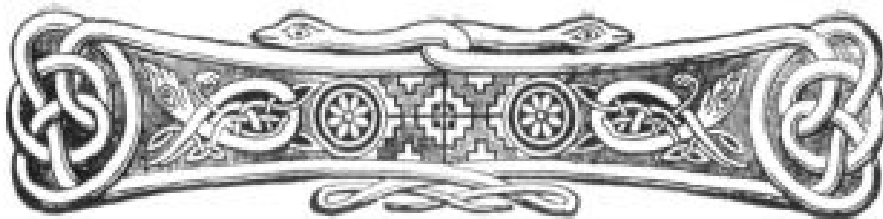

October 1, 2014

The meeting was called to order by the president, John Garahan at 6:45pm. The following Governors attended the meeting: John Garahan, Carl Ashby, Diane Lee, Rich Basler, Nick Fletcher, Gerry Yeager, Martha Nazak, Mary McGreevy, Linda Pheasant, Janie MacBryde, Julie Manahan and Stephanie Clark. Heidi Gregor, President of the Kerry Blue Terrier Club of Hawaii, also attended.

News of the passing of longtime member, Bert Tormey, was shared. John Garahan asked for a moment of silence to honor Bert. The Board of Governors agreed on honoring Bert next year at MCKC. A motion to dedicate the 2015 MCKC show to Bert was made by Martha Nazak and seconded by Richard Basler. Motion passed.

New officers were elected for the year: President, John Garahan; Vice President, Stephanie Clark; Recording Secretary is vacant; Corresponding Secretary, Bill Kearney and Treasurer, Carl Ashby.

Several Chapter Clubs are dealing with low membership numbers and a lack of participation by members. Those clubs include the Empire Kerry Blue Club, Philadelphia Kerry Blue Club, Texas Kerry Blue Club and Northern California club. These clubs are experiencing low entries at their shows combined with problems with membership numbers. Board members questioned whether the national club should be more aggressive and schedule events that are fun and informative. Questions of lack of interest in the sport and whether there is a lack of passion were raised.

Suggestions from the board include the need to make personal calls to members. When the club is looking for donations for things like trophies, members should not just rely on communications via Facebook and e-mail. We need to have them make personal calls to past donors and new participants. Example: Lucy Noe called everyone about the Futurity entry.

Bigger issue is how to include PERFORMANCE with the conformation, since performance events are attracting a number of entries. The club wants to encourage their participation.

**COMMITTEE REPORTS** were presented as follows:

**Health & Genetics** --- there was no report from the chairman. It was suggested that Dr. Natalia Samaj-Kunze be contacted about being part of this committee.

It was felt that she would be a great help with future clinics/seminars. She has expressed her desire to assist the Club in this area. It was also suggested that Nadine Vukovich be contacted as to whether she has an interest in helping with this committee.

**Handbook Committee** - HANDBOOK IS MOST CRITICAL!!! We need to sell ads. In order to do that, we need breeders to contact their buyers. We need to get a broader footprint of involvement from the membership. We should contact NON MEMBERS as well as AFFILIATE MEMBERS and NEW PUP OWNERS.

**FACEBOOK**—QUESTION are we responding to Facebook vs. USKBTC club? How can we follow membership with Facebook? Should we ask any person requesting Facebook membership on the USKBTC page to fill out affiliate membership application?

Rich Basler reported on some of the Southern California club activities.

Carl mentioned that nationwide entries at dog shows through July of 2014 was 66,000 dogs shown which is 3600 fewer than from July of last year. Reasons? Are there time and money pressures? Suggestion was thrown out as to whether shows should "DO 3 GRPS 1 day and do the remainder of the Groups the next day? This could be proposed by the AKC.

Generally the board agreed that REGIONAL clubs seem to have more "FUN" events. Perhaps, as a National Club, we need to look at their examples for better ideas. These ideas could include assistance with hospitality suggestions, for instance.

It was mentioned that we need better public relations and marketing for Kerry Blues.

**TROPHIES:** The question was raised as to whether we should continue with the present quality of trophies or should we consider spending less such as giving pins for the class second, third and fourth class winners.

**CHARITABLE FUNDS:** Linda Pheasant presented the financial report for Charitable Funds. Adding additional members to the Board of Charitable Funds was discussed. Governor Rich Basler stated that he had volunteered his services numerous times and was ignored. Motion was made and seconded to add Rich to the Board of Charitable Funds. After accepting the position, Rich spoke about the need to get our members involved and to make fundraising a goal of Charitable Funds. Rich Basler agreed to CHAIR Charitable Funds. The Board unanimously voted YES. The Board agreed to support Meet the Breeds at the Eukanuba

show and at Westminster in 2015. Melanie Fledges agreed to do a new Charitable Funds Brochure.

**RESCUE---** Treasurer, Carl Ashby, brought up the subject of Liability insurance for those involved in rescue work. The proposed premium is \$345 for 1yr with coverage up to \$1 million for public. The policy covers rescue volunteers up to \$15,000. Liability insurance for the Futurity is \$600. Carl is checking on liability for all chapter clubs to see whether it is possible to consolidate them under the USKBTC policy?

The premium for D & O (Directors & Officers) coverage for lawsuits \$815.00/yr. Carl Ashby recommended that we check additional insurers for better prices.

**PUBLIC RELATIONS---** Janie MacBryde suggested FREE puppy buyer packets to breeders from the US club. Also, the Board approved a one year free membership in the USKBTC for all new puppy buyers. This will include 3 copies of BLUEPRINTS to the buyers. There was also a suggestion of a New Puppy Page in Blueprints which would include pictures of puppies and their new owners.

**NOMINATING COMMITTEE---** John Garahan will chair the nominating committee as he is termed out this year. He will seek 2 Non Board Members to join him. It was suggested to get performance people involved.

**HANDBOOK---** the deadline for advertising was moved to moved to March 31, 2015. Suggestion was made to have Board members contact the membership and solicit for advertisements by dividing up the membership list and making personal calls, ie. 10 calls per board member by area.

**JUDGING---** The Club needs to establish a new and current judges list which will be the top 30 who get the most votes. The question was raised whether we can have only U.S judges for the concurrent specialty as it is a condition of the National Specialty. The Board voted to endorse the application of MONICA ADAIR as a JUDGE contingent upon her passing all requirements set forth by AKC policy. The Board would like to see more Kerry Breeders/owners approved as judges.

**TREASURER'S REPORT---** Carl Ashby presented the Treasurers report. If any members are interested it is available. It was recommended that the money for the 2013 Futurity be donated back to Charitable Funds since the payouts were so small. A motion was made from the floor to award the Futurity money as follows: 60% for Best In Futurity and 40% for Best Opposite. The individual class payouts would be removed. The motion was seconded from the floor and passed unani-

mously.

Yearly storage fees for the perpetual trophies is \$800 in a Pa. storage unit. Discussion followed regarding other options. John Garahan agreed to look into this.

**WEBSITE---** Support was offered for Anne Katona to take over duties of providing information for the AKC Gazette newsletter to fill in for Carol Kearney.

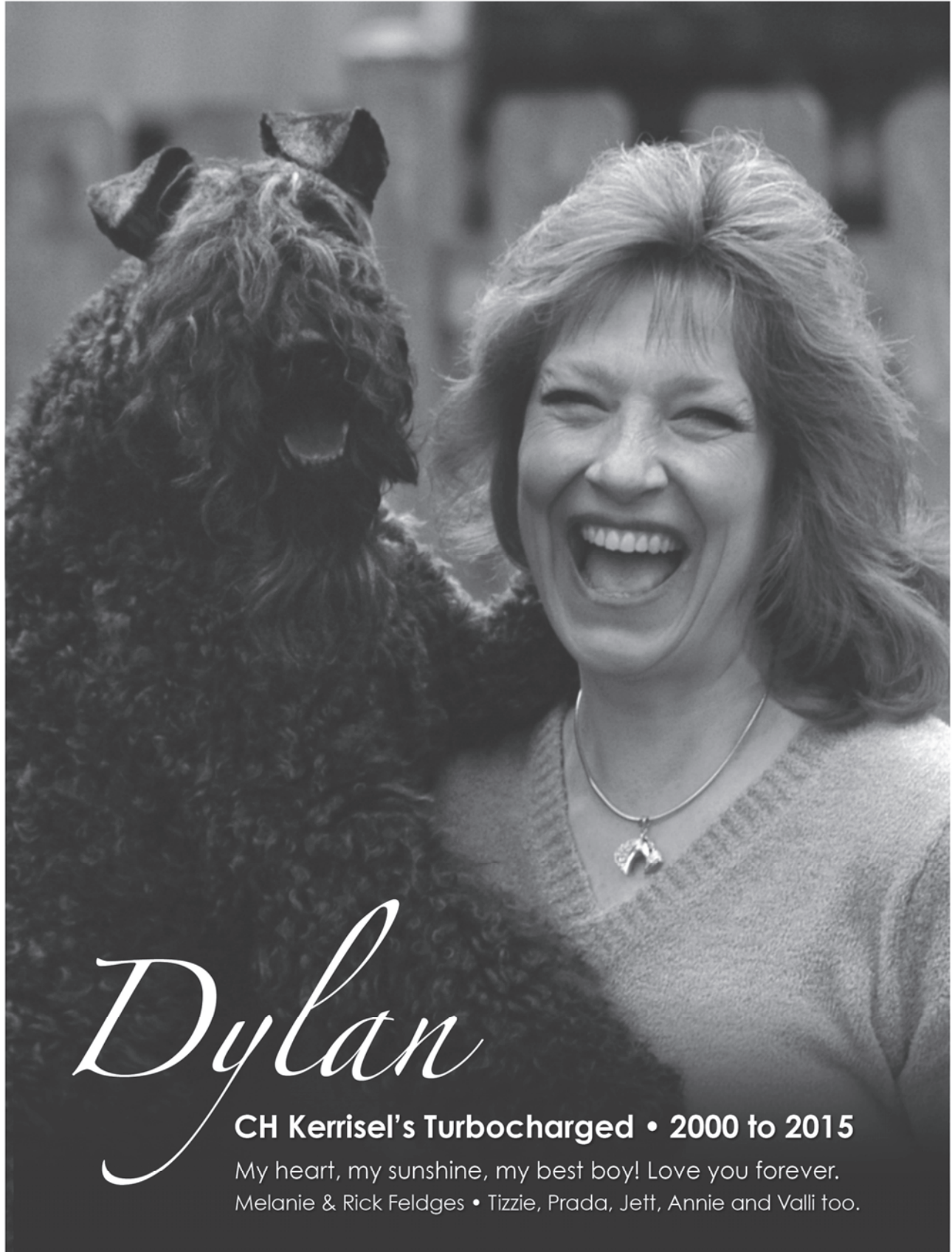

The actual numbers of kerries being shown in Texas is going down each year, the few new people that have been purchasing Kerry puppies are just not interested in joining dog clubs or showing, it's a common problem and the current members are all getting on in years. I am

## AVSAB Position Statement On Puppy Socialization

**THE PRIMARY AND MOST IMPORTANT** time for puppy socialization is the first three months of life.<sup>1,2</sup> During this time puppies should be exposed to as many new people, animals, stimuli and environments as can be achieved safely and without causing overstimulation manifested as excessive fear, withdrawal or avoidance behavior. For this reason, the American Veterinary Society of Animal Behavior believes that it should be the standard of care for puppies to receive such socialization before they are fully vaccinated.

Because the first three months are the period when sociability outweighs fear, this is the primary window of opportunity for puppies to adapt to new people,

animals, and experiences. Incomplete or improper socialization during this important time can increase the risk of behavioral problems later in life including fear, avoidance, and/or aggression. Behavioral problems are the greatest threat to the owner-dog bond. In fact, behavioral problems are the number one cause of relinquishment to shelters.<sup>3</sup> Behavioral issues, not infectious diseases, are the number one cause of death for dogs under three years of age.

**For this reason, the American Veterinary Society of Animal Behavior believes that it should be the standard of care for puppies to receive such socialization before they are fully vaccinated.**

While puppies' immune systems are still developing during these early months, the combination of maternal immunity, primary vaccination, and appropriate care makes the risk of infection relatively small compared to the chance of death from a behavior problem.

Veterinarians specializing in behavior recommend that owners take advantage of every safe opportunity to expose young puppies to the great variety of stimuli that they will experience in their lives. Enrolling in puppy classes prior to three months of age can be an excellent means of improving training, strengthening the human-animal bond, and socializing puppies in an environment where risk of illness can be minimized.

In general, puppies can start puppy socialization classes as early as 7-8 weeks of age. Puppies should receive a minimum of one set of vaccines at least 7 days prior to the first class and a first deworming. They should be kept up-to-date on vaccines throughout the class.

## The Process of Socialization:

Puppies should be handled from birth, learning to accept manipulation of all body parts. Every effort should be made to expose them to as many different people, well-socialized animals, situations, places, etc. as possible. Puppies should be encouraged to explore, investigate, and manipulate their environments. Interactive toys and games, a variety of surfaces, tunnels, steps, chutes, and other stimuli can enrich the puppy's environment. Puppies should accompany their breeders/owners on as many car trips as possible. These exposures should continue into adulthood to maintain an outgoing and sociable dog.

Puppy socialization classes can offer a safe and organized means of socializing puppies and more quickly improve their responsiveness to commands.<sup>4</sup> Each puppy should have up-to-date vaccinations and be disease and parasite free before entering the class. Where possible, classes should be held on surfaces that are easily cleaned and disinfected (e.g. indoor environments). Visits to dog parks or other areas that are not sanitized and/or are highly trafficked by dogs of unknown vaccination or disease status should be avoided.

Classes and at-home training should be based on positive reinforcement with frequent rewards praise, petting, play and/or treats. Positive and consistent training is associated with fewer behavioral problems and greater obedience than methods that involve punishment and/or encourage human dominance.<sup>4,5,6</sup>

Time must be scheduled for puppies to play alone with their favorite toys (such as stuffed food toys) or take naps in safe places such as crates or puppy pens. This teaches puppies to amuse themselves, and may help to prevent problems of over attachment to the owners. Continuing to offer dogs a wide variety of experiences during their first year of life is also helpful in preventing separation-related behavior.<sup>7</sup>

Proper confinement training using pens or crates helps to ensure that puppies have safe and secure places for rest and confinement. Puppies that are used to being crated will be less stressed if they must be hospitalized or be confined for travel by plane or car. Crates should serve as comfort or play areas.

Early and adequate socialization and programs of positive training can go a long way to preventing behavior problems and improving bonding between humans and dogs. While the first three months is the most important socialization period in a puppy's life, owners of puppies that have passed this milestone are strongly encouraged to continue to socialize their puppies to as many people, pets, and locations as is practical. However, owners of puppies displaying fear should seek veterinary guidance.

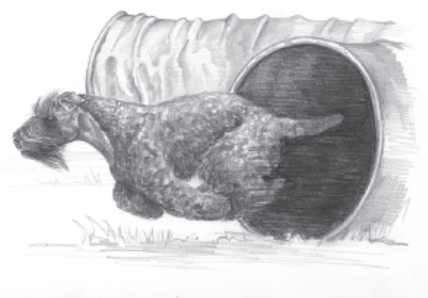

## Ouch, that hurts! (How thick is your skin?)

Objective: adjective \əb-'jek-tiv, əb-'/: based on facts rather than feelings or opinions : not influenced by feelings.

Recently, I was speaking to a fellow Kerry Blue Terrier exhibitor and breeder at a show we both attended and asked her if I could go over her young dog she was showing. She happily obliged, putting the dog up on the table for me to examine and standing back as I looked over various parts of his body, peered into his mouth, felt his shoulders, studied his expression, etc. As I concluded and remarked that he was a nice dog, she proceeded to tell me what she would change or improve upon him. The comments she made were right on the money and included an observation or two I had missed in that short session. She was not trying to sell me on how wonderful he was or that he would make a perfect match for my bitch, she was simply stating in a matter of fact way where she thought he could be better.

What did I walk away with after this encounter? A lot more respect and admiration for this breeder who had the ability to look at her own dogs with a critical eye and not feel personal failure or shame in recognizing their imperfections. This is not to say she wasn't proud of her dogs, she was and rightly so!

What is the true motivation for showing our dogs? Is it for self-gratification, a boost for our ego, the thrill of winning or ranking? Yes, it can be all that. Yet, isn't the real purpose to present our efforts to other breeders and exhibitors, inviting them to judge (yes, judge!) for themselves how our dogs stack

up to the competition (and breed standard), and whether or not they would make a suitable breeding prospect? If we are to improve our breed, we must be willing to put our dogs out there for everyone to see and accept and embrace the ensuing criticisms that will surely follow. After all, no dog is perfect...right?

We surround ourselves with friends, family, and mentors who support us—this is what keeps us going when times get tough. But, we need opposing views to challenge us, too, if we intend to improve. The ability to take in sometimes hurtful or negative criticisms with an open mind can help us grow to become stronger, wiser, and better than before. We don't have to agree with every assessment; there will always be detractors—those who may prefer a different style or have a dissimilar interpretation of the breed standard, or those just harboring petty jealousies—but even the harshest judgements may contain nuggets of truth that could be beneficial to our education, more so than the words of our friends who may hold back for fear of hurting our feelings.

Being objective when it comes to our own dogs is much harder for most of us than it is to find fault in our competition. While rarely do we appreciate unsolicited criticism (and approaching another exhibitor to “enlighten” them is plain rude), the ability to listen to negative comments without reacting defensively benefits us more than any possible praise given. If we can't accept hearing anything but accolades, we stop learning and become stagnant.

When I purchased my first Kerry Blue Terrier many years ago, I thought he was a quality show prospect. I had read the standard and felt he conformed pretty close: he had no major faults, his bite was

good, he was the proper size, had a correct coat, dark eye, and came from a long line of champions. After approaching a top handler to ask him about the possibility of showing him, he gently, yet bluntly, explained to me that he could probably finish my dog, but if I was really serious about breeding and showing, I should start over with the best quality bitch I could afford from a reputable breeder, otherwise I would always be playing catch-up to breed out the faults I was starting with. Though it stung at the time, this one piece of advice was the most valuable gift anyone could have given me as a novice, and I am grateful he chose to be straightforward and truthful rather than take the easy money. After swallowing my wounded pride and doing some serious introspection, I was able to have another look at my beloved dog through clearer eyes and admit he was not the specimen on which I wanted to base my breeding program. I could do much better—the breed deserved better—than mediocrity.

Successful breeders are open and honest in their evaluations of their own dogs. It's not based on feelings of love, dreams, hopes or loyalties to their pets, a person, or a particular line, it's based on facts and reality devoid of emotions. They take in valuable feedback, good and bad, incorporate what is important and useful information, and toss out the junk. With experience and an open mind, they have learned to recognize which is which.

So next time the critics start, step back, take a deep breath, and listen carefully; it could be something deserving of a heartfelt “thank you” later on down the road.

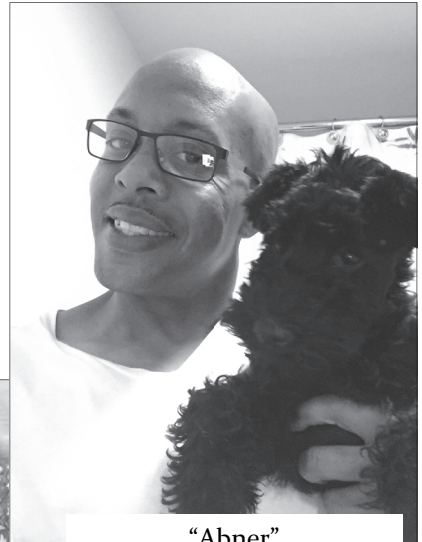

## **A Word from Charitable Funds...**

As many of you know the US Kerry Blue Charitable Fund was established in 2002. Its purpose was to serve the Kerry Blue Terrier in four important areas:

- 1) Rescue Fund** – this fund supports grants used to provide Kerry Blue Terrier rescue services.
- 2) Health and Genetics Fund** - this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier.
- 3) Education Fund** – the education fund supports education of all those interested in the Kerry Blue Terrier including publications, websites, and seminars.
- 4) General Fund** – donations to this fund are used to support the work of the other funds through internal grants to those funds. Undesignated gifts will initially be held in this fund.

Since the Fund was established we have worked diligently to build the assets of the Funds while undertaking major support of the PNA Research being done at the University of Missouri. To date we have awarded over \$20,000 in grants to support Health and Genetics, Education, and Rescue. The reality is that we must grow our financial resources substantially in order to having a meaningful impact and that means it will take many years to be in a position to have a significant impact on our core areas.

Since 2010, the USKBTC - Charitable Funds has honored 24 Kerry Blue terriers for their "heart" shown by their exceptional contributions to society and to individuals through the "Kerry It Forward" Awards. We are now accepting applications for the **2015 Kerry It Forward Awards** on the USKBTC website.

Kerries involved in public service are the unsung heroes of our Kerry community. If you are aware of a Kerry who meets the criteria listed below, and you are a USKBTC member, please consider nominating him or her. These special Kerries often do not seek recognition and owners may need your encouragement. This is our way of thanking them for their contributions. You may know of Kerries who have served in nursing homes, assisted living centers, counseling centers and hospitals comforting those who suffer. However, Kerries have also been teachers, and have been found helping children learn to read, through canine-assisted reading programs, building children's self-confidence. Some Kerries have been involved in other canine education programs, such as the Bite Prevention programs, teaching children how to approach a dog. Others have worked with crossing guards each day, helping children safely cross the street on their way school. Other Kerries have chosen a special one-time mission and have intervened in the daily life of a human companion to save a life.

Thank you, to all Therapy and Service Kerries, and to those who have performed as Exemplary Companion Dogs, past and present, for your service to our canine and Kerry community. This award recognizes the canine-humanitarian contribution to society and the individual through the following award categories:

**Category 1 Service Dog:**

Service or assistance dogs are trained to assist individuals with meeting special needs on a daily basis; these needs can be physical, psychological and/or emotional; examples include hearing, sight service dogs and alert response dogs who alert their human companions to seizures and other medical emergencies;

**Category 2 Therapy Dog:**

Therapy dogs are trained to provide care and comfort to patients and residents in medical care facilities, retirement communities, counseling centers and shelters; Examples include retirement communities; senior centers; veterans homes, military hospitals; healthcare facilities, hospitals, hospice and medical care facilities; children's hospitals, rehabilitation centers such as shelters for homeless, battered women and children; military and veterans hospitals and recovery centers;

**Category 3 Educational Service Dog (Therapy Dog):**

Educational Service Dog works with children in public and private schools in academic and special needs areas; Programs can include but are not limited to the Bite Avoidance programs in schools and organizations such as The Boys and Girls Clubs; Canine-Assisted Reading Programs; Safety School Crossing Program; Programs include Kerries teaching children how to interact with dogs and build a positive relationship with dogs;

**Category 4 Exemplary Companion Dog /Act of Exemplary Performance:**

Ollie" owned by Martha Turner, Wichita Falls, Texas. Ollie has gone from a homeless 2 year old rescue roaming the streets to a therapy dog comforting those who need a gentle Kerry paw.

Martha writes: Ollie is my second therapy dog. He came from a puppy mill, was found roaming the streets, and at two was found in a shelter and saved by the Kerry Blue Terrier Club of Texas. Ollie had been neglected, abused, and starved. He came with health problems, dread locks, was lame, and weighed only 27 pounds. At seven he is a happy, confident, forty-pound therapy dog. In socializing Ollie, it did not take a village, but a hospital. As the staff of HealthSouth Rehabilitation Hospital loved my other Kerry Blue Terrier, the hospital administrator allowed Ollie to train with them. Everyone went out of their way to socialize and encourage an insecure rescue into a happy therapy dog. There are employees that will come find us if we miss them on our visits. They say they can't miss their "Ollie fix." Ollie was given a plaque this year for his volunteer service to HealthSouth.

In addition to nursing homes and the rehabilitation hospital, Ollie had weekly visits to a residence home for developmentally challenged women. A severely autistic resident could sit still long enough for a quick pat and a smile. I think she knew that Ollie loved women and understood that no matter what their condition or age, all women want to feel that they are pretty. Ollie does that; he makes you feel beautiful. Many patients have told me that they feel better already just seeing him. Some of the out-patients have said that Ollie makes it worth getting up and going to therapy. One patient who had worked with the humane society for 30 years praised him as being a wonderful therapy dog and was amazed that he could be so sweet and trusting after having been so badly abused. Ollie's only weakness as a therapy dog is that he loves his job so much that he wants to stay at the facility. When it's time to leave, Ollie lowers his head, squares his shoulders, plants his feet and sits. Glaring at me stubbornly, he refuses to move while patients and staff laugh boisterously at the standoff. Usually, a little subterfuge is called for as an employee or patient feigns imperative need of Ollie's attention. Gallantly and with great dignity Ollie is up and moving to administer affection to the one in need. Patients express their gratitude for his visits in various ways. Oftentimes smiles instantly break out across

the room. Sometimes, there are tears from feeling abandoned and neglected. As they release their pain, Ollie comforts them. He knows; he understands; he's been there. Ollie is a testament to the resiliency of the Kerry spirit. With all the love, affection, and understanding that he can give, Ollie Kerrys it forward.



Martha Turner has two Therapy Dogs. Tillie, Breeder Laverne Prewitt; Sire: Cormac Across the Rubican and Dam Glencavan Katiec Fancy, Kerries It Forward with Alzheimer's patients and hospital patients at Healthsouth Rehabilitation Hospital in Texas.

Martha writes: Kerry Blue Terriers are exceptional dogs and Tillie is an excellent ambassador of the breed, especially for Kerries as therapy dogs. We actually began our training with my father, who had Alzheimer's. Most of time he wouldn't know me or appear cognizant of the world around him. However, enter and/or exit Tillie and he would say, "Where's that dog?" Tillie is simply a natural. She has that Kerry attitude and believes everyone is entitled to adore her and tell her how beautiful she is. Ever promoting an equal adoration policy, Tillie makes sure that all have an op-

portunity to express their love and admiration for her. Tillie is very successful in soliciting accolades, smiles, and chuckles. She radiates compassion and warmth; you can feel tension leave the patients upon her arrival. Their faces soften, their eyes light up, and frown lines are instantly replaced by a widening and joyful smile. Many times otherwise uncommunicative patients reach out, interacting freely and tenderly caressing her coat or vocalizing how beautiful and good she is. She seems to make them feel better as they connect with life through her vitality. Tillie was first registered as a therapy dog at two years of age; she is now eleven. Since my retirement on 2007, we have visited nursing homes, Alzheimer's units, and rehabilitation hospitals on a weekly basis averaging 50 contacts per visit. She is the first exposure most people have to a Kerry and their first response is enchantment. In fact, enchanted is probably the best description of her effect on patients and staff alike. One therapist loves her so much that she named her own pet Tillie. A blind resident loves visiting with Tillie and always tells her how beautiful she is, beauty radiating from both hearts, the giver and receiver. Patients who are bedfast will ask her to lie down alongside them. Upon request Tillie gently hops right up on the bed and snuggles lovingly providing comfort and affection in way only those needing hugs and companionship can explain. These patients always tell me that she has made their day. Tillie's tail is always a blur and elicits lots of laughs. Even though they would love to touch her tail, I tell them that this is her power source and can't be stopped. Tillie has been visiting HealthSouth Rehabilitation Hospital since 2008. In appreciation for her years of volunteer service, she was presented a plaque this year. Although she had rather have all the visits and attention for herself, Tillie has paved the way for my second therapy dog, Ollie. Our Kerries continue to touch lives, everywhere they go.

## Insight into vaccinations

There is a misconception, that vaccines “give us protection” against disease. But that’s what hyper immune serum and colostrum are for. The administered vaccine mimics natural infection and as such, teaches the immune system to fight the disease. The body’s own immune system is the true defender against the infection. And just like in any game, the line-up has some major players.

In the world of immune system, they are 3 types of white blood cells: Macrophages, B Lymphocytes and Memory cells.

- ◆ **Macrophages** recognize the foreign substance (germs, tissue cells, chemicals, toxins or vaccine), attack and digest it and leave behind “the left-overs” called **antigens**. The body recognizes the antigens as dangerous and as such, it sounds the alarm for B-lymphocytes to arrive. **The vaccine is an antigen.**
- ◆ **B-lymphocytes** (or Plasma B cells) produce **antibodies**, which attack the antigens by bonding with them and coating them. The antibody is a protein used to identify and neutralize the antigen and signal to other cells to come and destroy the threat. **We can measure the level of antibodies in the body by serology, which we call “titers”.**
- ◆ **Memory cells** are some of the B cells stored for later and are responsible for what is called a secondary response. As these cells “remember” the pathogen from the previous encounter, they respond faster and bind better to it, allowing the body to fight the disease more efficiently. **This is the reason for booster vaccines.**

There are many factors influencing the productivity of the immune system - the age, the environment, the breed, overall health and, in the case of puppies, the mother. Any insult to the body can reduce the ability to produce good quality immunity. That includes stress, malnutrition, co-infections with other bacteria/viruses, and parasites as well as many environmental factors, including overcrowding, previous exposure, contagiousness and stability of the infection and additional ways of exposure (dog show/work competitions, economically challenged areas, wild life, etc.).

In addition, some animals as well as humans belong to the group of “non-responders” or “poor responders”. They fail to develop antibody response after repeated revaccination and are not protected from the diseases, serving as a reservoir. The non-responder status is believed to be genetically controlled in all species including certain breeds of dogs.

So how about the puppies? At first, the puppies get the immunity via colostrum from the dam. But the transfer is successful **only** if the dam has high levels of antibodies, and for that the bitch must be previously vaccinated or infected. The other variables to be considered are the litter size and the birthing itself. In addition, the availability and access to colostrum is easier for the litter of six (6) versus a litter of 12. Pups born naturally usually bond with the bitch immediately versus pups born by C-

section which can experience delayed bonding; milk production can also be delayed by 2-3 days in bitches who have a C-section.

Over 90% of the maternal antibodies are passed via colostrum, with the maximal absorption at 8 hours after birth, decreasing significantly after 24 hours of life. There is no colostrum absorption after 3 days. To provide the puppies with a good quality colostrum, it is important to encourage nursing within 3 hours of birth, from a well vaccinated bitch. The other options for protection are use of hyper immune serum or early vaccination. Remember that the colostrum and the hyper immune serum contain antibodies, and as such they do not stimulate the body’s own immune system.

The idea of the protection against disease by vaccination is very old. Evidence exists that the Chinese employed small pox inoculation as early as 1000 CE. Edward Jenner performed the first vaccination against small pox in England in 1796 and in 1885 Louis Pasteur prepared the first human rabies vaccine in France. Many advances were made after that.

There seems to be a misconception in the general public about who decides about the vaccine type and the vaccination schedule. Knowing the amount of data there is in the world, with new discoveries coming every day, the advice should never come from one person’s opinion only. Europe and Asia’s World Small Animal Veterinary Association (WSAVA) established the Vaccination Guideline Group. Their goal is somewhat universal: “*To maximize the protection of dogs and cats from infectious and sometimes zoonotic disease, whilst simultaneously minimizing the risk of adverse reaction post vaccination.*” Also in the USA and Canada, representatives from academia, private practice, government and industry created groups that evaluate the benefits and the risks of the vaccines currently available on the market.

These groups combine experts in fields of immunology, infectious diseases, internal medicine, law and clinical practice. Opinion from every field has its value. In addition to the American Veterinary Medical Association (AVMA) Council on Biologic and Therapeutic Agents (COBTA) and the American Association of Feline Practitioners (AAFP/AFM) Advisory Panel on Feline Vaccines, there is also the American Animal Hospital Association (AAHA). The AAHA established the Canine Vaccine Task Force in 1993 and released the newest vaccination guidelines for dogs and cats in 2011. The guidelines are supported by professional, scientific and clinical evidence as well as published and unpublished documentation. The guidelines discuss types of vaccines, as well as serological testing, adverse effects and legal implications. The AAHA Vaccine Task Force 2011 guidelines are readily accessible at:

There is an explanation for grouping the vaccines into two (2) groups of core and non-core vaccines, and the reason for using them every three (3) years vs. yearly. Guidelines are not intended to represent a universal or standardized protocol applicable

to all dogs. Instead, they are intended to guide decisions leading to the development of a rational vaccination protocol. The variations may be warranted based on the individual needs of a patient. To further understand where the relative flexibility comes from, consider these facts. In puppies, we face two **important immunization challenges**:

- ◆ The immature immune system
- ◆ Maternally derived antibodies (MDA)

For the puppies immune system to respond to vaccine, they need to be at least 4 weeks old (the age for administration of the vaccine depends on the manufacturer's recommendations). Circulating MDA in a puppy's system are also responsible for the response to the vaccine - namely the levels of the titer and the length of the time the maternal antibodies persist. The response to the vaccine can differ from puppy to puppy for the above mentioned reasons. Interference of the vaccine with MDA is considered one of the most important factors in immunization failure. And regardless of our efforts, there may still be a window when the declining titer of MDA does not protect against the disease but is still able to inhibit the vaccine. A variable period of time without active immune protection will remain and an infection is possible.

The clinical practice is to immunize children and animals repeatedly and is based on the fact that the MDA decompose over time. Repeated vaccination ensures that they are immunized when MDA have been metabolized. It is not practical to establish the level of maternal antibody in every puppy presented for initial vaccination with core vaccine (parvo, distemper). That's why it is recommended for puppies to receive vaccine every 3-4 weeks between 8 to 16 weeks of age. The final dose administered at 14-16 weeks should insure at least one dose of vaccine at an age when the level of MDA is insufficient to prevent an active (vaccine induced) immunity. One of the **exceptions** to this schedule applies to those puppies with no MDA (born to an unvaccinated dam or who received no colostrum). They can be vaccinated earlier and/or their final vaccine dose can be administered at 12 weeks of age.

Some owners are instructed to vaccinate differently or keep puppies "in the bubble" until fully vaccinated (beyond the age of 16 weeks). The 2008 American Veterinary Society of Animal Behavior clearly states that it is considered a standard of care to socialize the puppies prior to the time they are fully vaccinated. That includes as many new people, animals, stimuli and environments as can be achieved safely and without causing overstimulation manifested as excessive fear, withdrawal or avoidance behavior.

### **Incidence of vaccine adverse events (AES).**

AES is defined as any undesirable side effect or unintended effect (including the lack of desired results) associated with the administration of a licensed biological product (vaccine). The reasons why the vaccine fails, is usually due to these 3 possibilities:

- ◆ Sufficient amount of MDA blocks the vaccine
- ◆ The vaccine is not immunogenic- if the vaccine was stored or transported improperly and lost its effectiveness – this can happen with vaccines ordered from online suppliers and used at home
- ◆ The animal is a poor or non-responder

The other reasons for AES are derived from the process of manufacturing the vaccines. Although the research is progressing towards less risky options, the majority of current vaccines are based on injecting the disease causing bacteria and viruses themselves. They need to be grown in the environment mimicking the infected animal's tissue. The growth extract contains sugars, salts and various meat sources with some requiring an additional nutrients provided by serum and blood.

After the bacteria/viruses are harvested, they are purified and concentrated, the growth medium/cellular debris is removed and adjuvant, preservatives and stabilizers are added. Although purification methods are improving, the harvested germs are not 100% free of the growth medium. The adjuvant has two functions. It improves antibody production by stimulating an inflammatory response and decreases the dose volume size by decreasing the amount of the antigen (bacteria, virus) needed. The preservatives and stabilizers prevent the vaccine from losing its potency over time, while shipped and stored.

**Do some vaccines cause more adverse reactions than others?** The answer is yes. The reason goes back to the manufacturing process, and there can be multiple causes: the antigen itself (virus, bacteria); the adjuvant; the serum or cellular protein; or a combination of vaccine components. Vaccines are grouped not just to core and non-core, but also to non-infectious and infectious.

The non-infectious vaccines contain inactivated or killed bacteria/virus, or a part of them in the form of a subunit or plasmid DNA. They protect the dog against Rabies, Influenza, Corona virus, Leptospirosis, Lyme disease and Bordetella (in injectable form). The diamond rattle snake *avenomous* vaccine belongs to this group as well. Since these vaccines do not infect the animal, they need to contain adjuvant, to provoke the body's immunity response by creating inflammation. Although they are safe, as the dog will not acquire the disease after vaccination, the immunity requires more time to develop. Immunity requires a minimum of 3 weeks: 2 doses separated by a minimum of 2 weeks (usual recommendation is 3-4 weeks) plus an additional week for the antibody production after the second (booster) vaccine. Non-infectious vaccines are more likely to produce local and systemic adverse events.

The infectious vaccines are also called attenuated, avirulent or modified live, and some of them are prepared by a recombinant technology. The infection-causing germ is weakened so as **not** to cause the disease. These are the vaccines against distemper, parvo, Adenovirus/hepatitis, Bordetella (intranasal or oral form) and parainfluenza. They do not require an adjuvant, but as they are live, they may be deactivated during shipment, storage or by

a chemical route. So the manufacturer adds preservatives and stabilizers.

There are no adequate studies about the treatment of AES. The usual approach includes non-steroidal anti-inflammatory drugs like Rimadyl, antihistamines and/or steroids. Sometimes the omega fatty acids and homeopathic remedies are added. Monitoring of the patient for at least 30 minutes post vaccine is recommended, although the acute reaction can develop for up to 3 days. The possible ways to avoid repeated AES include splitting of the vaccines, trying the same vaccine but different manufacturer, increasing intervals between series and in some cases offering serology (the measuring of the level of antibodies) instead of vaccination itself.

The serological testing is currently applicable for the Distemper and Parvovirus only. Rabies titers are also possible, but they are not taken into consideration if your dog bites a person, due to the zoonotic (transmissible to people) nature of the rabies and nearly 100% death rate. With other vaccines, the serological testing is not applicable because the vaccine creates only short-term immunity or there is not known correlation between the antibodies and protection. The results may vary among the type of the test and between the labs running the tests.

It is not recommended to decrease the dose of the vaccine by administering a smaller total volume (half of the vaccine) because your puppy is small **or** mixing the powder part of the vaccine with a half volume of the liquid. The volume (1 ml or 0.5 ml) as recommended by the manufacturer generally represents the minimum immunizing dose; therefore the total amount should be given to induce a protective immune response. The majority of the vaccine manufacturers have immunization support guarantee and will cover diagnostics and treatments if the dog contracted the disease after the vaccination, but that is **only**

if the vaccine was used according to their directions and in the veterinary office. Please ask your veterinarian for further details.



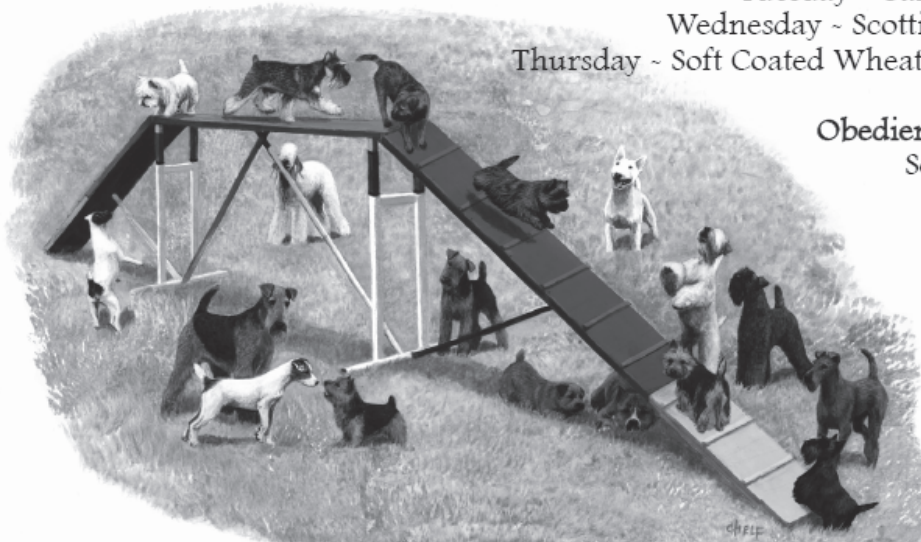
