ALL breeds and events involving dogs including the Kerry Blue Terrier are under attack by organizations which do NOT wish us well. Unless we collectively thwart them through a concerted effort, onerous laws will be passed and dog related sports will vanish. This fight, in my opinion, must be waged behind the AKC Banner since it is clearly the leading registry in the United States.

This takes money. With fewer than half the puppies from AKC litters becoming registered a major source of AKC income has declined dramatically. In an attempt to correct this problem, the AKC Registration Pledge Challenge program has been developed. This pledge is a call to action for AKC Member Clubs and the USKBTC has signed up for this program. The most effective way of insuring registration is for breeders to complete the papers in the new owners name when the puppy is sold. Include the fee in the price of the puppy, and personally forward the papers to the AKC. To take the registration pledge, please see the flyer elsewhere in *Blueprints*.

The AKC has launched a new canine legislation tracking system. This service enables you to check the status of canine legislation in all 50 states and at the federal level. Please go to **[www.AKC.org/canine-legislation](http://www.AKC.org/canine-legislation)**. This brings you to a page with a clickable map of the U.S. To view federal legislation click on the US Fed icon.

Thanks primarily to the efforts of Susan Dunivant, a letter was sent to the AVMA in opposition to their position on tail docking. Hopefully the AVMA will reconsider their position based on reasonable arguments from within the organization and input from those impacted. My article on this topic will be printed in the August issue of the *Gazette* in the Kerry Blue Terrier breed column.

The USKBTC Board passed a motion to contribute \$100 to each affiliated club holding a second specialty in the same year. These specialties can be back to back or at a different time of the year.

Older Futurity Prints are being offered to all affiliated clubs for utilization at their events. The cost is minimal. Please contact Barb Beuter for details.

Being term limited off the Board, this will be the last *Rogers' Ramblings*. I wish to thank ALL of the governors with whom I've served these past six years and ALL the members who have volunteered for the many tasks necessary to make all USKBTC and affiliated club events successful.

Dear Dr. Golab,

It is the aim of the membership of the United States Kerry Blue Terrier Club, represented by its board of governors, to defend the practice of docking tails in our breed based on practical reasons. Thus we provide below sound arguments against the AVMA recommendation which seems to be driven by Animal Rights agenda.

Please understand, all caring and responsible breeders support animal WELFARE, a humanitarian prerogative, however they do NOT support Animal RIGHTS, which is a political movement.

*Animal Right's Argument #1: Docking puppies is cruel and painful.*

**Responsible Breeder's Response:** The tail bones in a pup at 3-4 days old are still only partially formed and the nervous system undeveloped and therefore the level of pain is less and fleeting. A parallel can be drawn comparing tail docking to human circumcision aside from the fact that the pain of circumcision appears to linger considerably longer than that of either tail docking and dew claw removal combined.

A young lamb or calf at birth is developed to the extent that it can stand and walk with the mother within minutes of being born. These animals are considered "flight" animals and necessarily must be more developed at birth, especially neurologically. A puppy, like a human, is essentially helpless for quite some time after birth. The pup is still developing sight, hearing, and the nervous system for many days after birth, just as the human infant. These animals, including the human, are considered "nest" animals and are less developed and are dependent on nurturing at birth and beyond, thereby not requiring a fully operational nervous system.

A very well reasoned argument proving the difference in development in various animals (including humans) is one made by Prof. Dr. R. Fritsch, Clinic of Veterinary Surgeons Justus Liebig University. Dr. Fritsch cites the similarity of human and dog infant physiology as it affects the ability to feel pain, comparing this to that of other animals more advanced in neurological development such as herd animals, including sheep, which are routinely docked. Dr. Fritsch concluded that the docking procedure in 4 day old puppies does NOT result in any serious pain. Please read the entire report in full at: <http://www.cdb.org/vets/fritsch.htm>

The Kerry Blue Terrier is a very exuberant dog and even in the home situation can damage its tail by striking it against furniture or other household furnishings. In the field the Kerry Blue Terrier has been and is used as a go to ground hunter for vermin. In order to remove the dog from an earth tunnel or den, the tail provides a means to carefully pull the dog out of the tunnel

or den. This is the only body part the hunter can reach to safely extract the dog to prevent serious attack against the dog from the prey. In the close confines of the tunnel or den the tail can become turned back on itself as the dog backs out, or as the handler uses it to signal removal. This can result in a sprained or even broken tail. Docked tails are stronger and rarely damaged.

Once damaged, the tail is extremely difficult to heal, whether it be broken or split, sometimes requiring amputation later in life when the dog must be placed under general anesthetic causing undue stress. Pain post surgery and difficulty in keeping the dog from re-damaging the wound is always an issue.

*Animal Right's Argument #2: Tail docking is a dangerous procedure and results in later health issues.*

**Responsible Breeder's Response:** Nothing could be further from the truth. When done properly, the procedure is quick, there is very little vascular involvement, therefore less chance for infection and the puppies bounce back immediately from the procedure. It is the rare docking surgery that goes awry. This is in stark contrast to the much ballyhooed early spay neuter currently applauded wherein all manner of serious chronic conditions can develop, including chronic incontinence in young dogs, CCL rupture, hip dysplasia and other serious medical issues. reference: <http://www.caninesports.com/SpayNeuter.html> Early Spay-Neuter Considerations for the Canine Athlete One Veterinarian's Opinion© 2005 Chris Zink DVM, PhD, DACVP

What is more, experienced breeders who routinely dock tails report that within hours after docking, puppies exhibit renewed vigor and even weaker pups seem to experience a "jump start" to their energy levels and surge ahead in developing strength and motor skills.

*Animal Right's Argument #3: Tail docking is done only to win shows or for cosmetic reasons.*

**Responsible Breeder's Response:** The Kerry Blue Terrier has been around since the 19th century and earlier. Historical references prove the tail was docked, as well as proof in early painting and photographs reflecting this fact. The Kerry Blue Terrier was not exhibited in any numbers until the early 1920s, therefore docking is certainly NOT done to win at shows. Docking is performed to save the dog pain and medical hardship due to injury in adulthood.

*Argument #4 Tails are required for balance while running, or for swimming*

**Responsible Breeder's Response:** Despite this argument, no dogs have ever been proven to fall over due to the lack of a tail. A docked tail does not result in a dog exhibiting poor balance or difficulty moving properly. This ridiculous argument is readily disproved by comparing the movement of a docked Kerry Blue Terrier with an undocked one. However, while both dogs are speeding around and doing the typical breed mid-air turns and leaping, the Kerry with the docked tail will be LESS likely to suffer tail damage.

Many docked breeds, including the Kerry Blue Terrier and even fully docked breeds, are excellent swimmers and are very capable of making short turns and efficient movements in water, thereby disproving another ridiculous argument.

*Argument #5 Tails are required for expression.*

**Responsible Breeder's Response:** The average human believes the tail is the most accurate barometer of a dog's mental state, yet full body language as used by other dogs to determine this state is much more reliable. Even fully docked dogs can easily give a full range of emotions readable by both dogs and humans. Suggesting an undocked tail is necessary to make an accurate reading on a dog's disposition is a silly and specious argument.

*Argument #6: Docking tails is Cosmetic Mutilation.*

**Responsible Breeder's Response:** "Cosmetic Mutilation" is a catch-phrase, carefully coined by radical animal rights advocates to elicit maximum shock value with the aim of squelching any logical consideration. It is a carefully contrived wording guaranteed to misrepresent a centuries old practice developed for the welfare of a working animal. This term is specifically designed to bring emotion into the argument, thereby relegating logic and science to the very dim background. Emotion is hard to argue against because people fooled into relying on emotion rather than thinking logically are caught up in their 'feelings' thereby rejecting out of hand any intelligent discourse. Pejorative terminology is a weapon used to great effect by animal rights advocates, entirely designed to elicit emotional response and destroy logical discourse.

*Argument #7: Other dogs don't have their tails docked.*

**Responsible Breeder's Response:** The practice of docking a hunting/working dog's tail was generally done for practical reasons, specifically to avoid more serious and extensive damage in later life. Level of activity and breed specific proclivities (jumping, navigating close quarters, digging into earth) may result in tail damage while at work or play. While other breeds may not benefit from the practice, Kerry Blues as stated earlier, are extremely active dogs and are prone to acrobatic activities in work and play, thereby making them prone to tail damage.

*Argument #8: Other countries are banning tail docking.*

**Responsible Breeder's Response:** While this is true, it has proven disastrous for many working dogs. Many countries having banned tail docking are currently re-considering if not totally reversing their prior stance, making lawful docking of hunting breeds for humanitarian reasons. Denmark's Anti-docking law specifically excludes five hunting breeds. Several anti-docking dog laws are being reconsidered due to the number of reported tail damages in all traditionally docked breeds.

We respect that the AVMA acts in what it believes is in the best interest of dogs. We share the concerns of the AVMA that all creatures must be treated with respect and dignity and our members strive to assure the health and well being of their Kerry Blue Terriers. That is why our members dock their tails and remove their dew claws....to prevent injury as they do the job for which they were bred, We, therefore, respectfully request that the AVMA review this policy immediately. ## **Avoiding Heat Related Injuries in Dogs** (Reprinted with permission of the author, Nate Baxter DVM.)

The first thing that needs to be understood is that dogs and people are different enough that most of the info cannot cross lines. I do not profess to know what the appropriate procedures for people other than what I learned in first aid.

Dogs do not lose enough electrolytes thru exercise to make a difference, but if the dog gets truly into heat stroke the physiology changes will make them necessary. BUT oral replacement at that point is futile, they need IV and lots of it.

### **Cooling**

Evaporative cooling is the most efficient mean of cooling. However, in a muggy environment, the moisture will not evaporate so cooling does not happen well. I cool with the coldest water I can find and will use ice depending on the situation. The best way is to run water over the dog, so there is always fresh water in contact. When you immerse a dog in a tub, the water trapped in the hair coat will get warm next to the dog, and act as an insulator against the cool water and cooling stops. If you can run water over the dog and place it in front of a fan that is the best. Misting the dog with water will only help if you are in a dry environment or in front of a fan. Just getting the dog wet is not the point, you want the water to be cool itself, or to evaporate.

For MOST situations all you will need to do is get the dog in a cooler environment, i.e. shade, or in the cab of the truck with the air conditioning on (driving around so the truck does not overheat and the AC is more efficient). Up to a couple of years ago, I was very concerned about my dogs getting too hot in the back of my black pickup with a black cap. A new white truck fixed a lot of that problem. When I had one dog I just pulled the wire crate out of the car and put it in some shade and hopefully a breeze. But having 2 dogs and running from one crate to another, that was not feasible. So I built a platform to put the wire crates on, which raises the dog up in the truck box where the air flow is better. Then I placed a 3 speed box fan in front blowing on the dogs with a foot of space to allow better airflow. I purchased a power inverter that connects to the battery and allows the 3 speed fan to run from the truck power. It has an automatic feature that prevents it from draining the battery. When I turned that fan on medium I would find that the dogs were asleep, breathing slowly and appeared very relaxed and

comfortable in a matter of 20 minutes or less, even on very hot muggy days.

### **Alcohol**

I do carry it for emergencies. It is very effective at cooling due to the rapid evaporation. It should be used when other methods are not working. You should be on your way to the veterinarian before you get to this point. We recommend using rubbing alcohol, which is isopropyl alcohol, not ethyl, for those of you not aware. So do not try to drink it. Alcohol should be used on the pads and lower feet area where there is little more than skin and blood vessels over the bones. Use a little bit, and let it evaporate, you can use too much as some is absorbed through the skin. There are concerns about toxicity, but you have to get the temperature down.

**UPDATE NOTE - alcohol has fallen out of favor with ER specialists! Use it only as a last ditch effort if nothing else works.**

I purchased those cooling pads, but found that the dogs would not lay on them. I would hold them on the back of a dog that just worked to get a quick cool, but have not use them for years. I also bought a pair of battery operated fans but found them pretty useless. Spend your money on the power inverter and get a real fan.

### **Watching Temperature**

If you feel your dog is in danger of heat injury, check its temp and write it down. Keep checking the temp every 3 minutes. I recommend to get a "rectal glass thermometer. The digital ones for the drugstore I have found to be very unreliable. Don't forget to shake it down completely each time. Sounds silly, but when are worried about your companion, things tend to get mixed up.

### **This is VERY IMPORTANT!!**

Once the temp STARTS to drop, STOP ALL COOLING EFFORTS. The cooling process will continue even though you have stopped. If the temp starts at 106.5, and then next time it drops to 105.5, stop cooling the dog, dry it off, and continue monitoring. You will be amazed how it continues to go down. If you do not stop until the temp is 102, the temp will drop way too low. I cannot emphasize this point enough.

When the dog is so heated that it is panting severely, only let it have a few laps of water. Water in the stomach does not cool the dog, you just need to

Each year, since 1999, the American Kennel Club has honored the canine-human bond with the AKC ACE Award of Canine Excellence, honoring those dogs who have contributed to others lives, in the following five categories: Search and Rescue; Therapy; Service; Exemplary Companion; and Law Enforcement.

It has been an honor for me to follow Beckett this past year, in her work at Double Branch Elementary School in Wesley Chapel, FL, and nominate her for the AKC ACE AWARD in the category of Therapy Dog. Beckett is owned by Reatha and Jim Omodio, Wesley Chapel, FL. You may recall reading about Beckett and her work with the children at Double Branch Elementary School in an earlier issue of Blue prints.

This is the "rest" of the story.

**Congratulations Beckett on your Nomination for your  
AKC ACE AWARD!**

School may be out but it is only the beginning for Beckett and her friends at the Double Branch Elementary School. Beckett and her three other "Tail Waggin' Tutors," as they are called, are very much "a success" this year in Wesley Chapel, FL. So much so, that the principal, Ms. Peggy Lewis and the teachers dedicated the school yearbook to the Canine Assisted Reading Program. They have continued the program for next year and are adding another dog, since the program is so successful with students struggling to read.

As you can imagine, reading is small part of what she brings to these children. Beckett is a very large part of these children's lives.

Below is her story.

“Beckett” works silently with second and third graders struggling to read.

What she achieves is far more than reading skills.

At one of the most critical times of development in their young lives, “Beckett”, a 6 year old Kerry Blue Terrier, gives her full attention, without criticism and without judgment, unconditionally to seven and eight year old children at the Double Branch Elementary School, in Wesley Chapel, Florida.



The way to improve reading skills is to read aloud and practice. That is easy to say, unless you are 7 years old and do not read well. From the moment “Beckett” enters the school, she immediately goes to work. Beckett meets individually with children every week who have not yet met the reading requirements of their grade levels. She does not laugh when they struggle. She does not correct them when they mispronounce a word. She is not harsh. She is not critical. She provides a paw of encouragement. “Beckett” and her Reading Buddy work it out, between them. No questions asked. Just love. In addition, they learn.

They love her and she loves them.  
Then magic happens.  
They find their confidence and courage.  
Then they find their voice.

“Beckett’s” students bring books they think she would like to hear them read to her. Teachers reported that some of her students were “caught” reading at their desks, when they should have been working on other projects. One child’s reading score increased by 400 points. These are the type of “problems” every teacher would like to have.

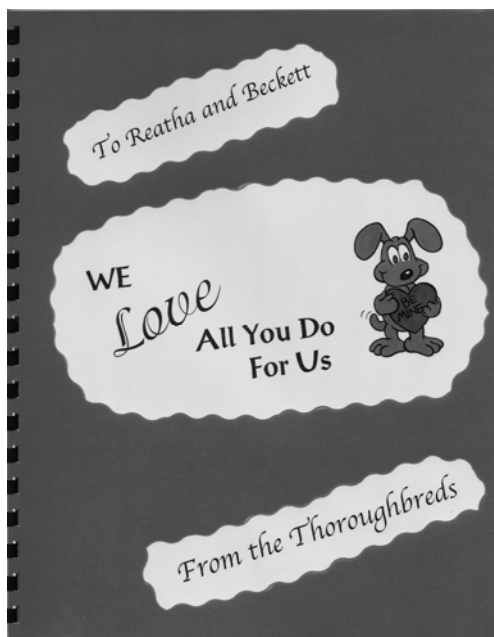
Little did owners Reatha and Jim Omodio, of Wesley Chapel, Florida know, when naming “Beckett,” that she would follow in the footsteps of famous Irish literary namesake, “Samuel Beckett.” He even writes of his Kerry Blues in his literary works. Although Beckett is actually named after Reatha's mother, the name and Beckett's affinity to working with children in reading is an interesting coincidence!

Today, Reatha must spell the word "s-c-h-o-o-l" or Beckett becomes so excited that she thinks that it is time to go to school! Any way that one chooses to look at it--"Beckett" has definitely found her calling. The canine-human bond is alive and well in this Kerry Blue Terrier!

At the end of the year, Beckett was invited by two of her Reading Buddies to attend a Parent-Child school party. The invitation was a little different than she expected. She was invited by two of her students to "stand in" as two of the children's parents who were unable to attend. She was very honored and everyone had a great time.



All of the children participating in the Extending Reading Program at Double Branch Elementary School have now met the reading requirements to advance to their next grade. The program has been extended to the 2009-2010 year.

Principal Ms. Peggy Lewis and the Teachers of Double Branch dedicate the Double Branch Yearbook to their "Tail Waggin' Therapy Dog Reading Program" because of the impact upon the students- not only as a reading program, but also for the impact this program has had upon their young students' lives. When asked why he liked reading to Beckett, one child said, "I like reading to Beckett because she shows me respect."

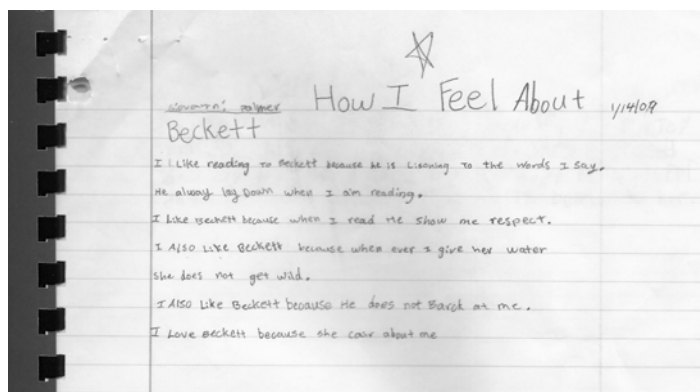
As another teacher stated, "Beckett's love and patience will be etched on the memories of these children for the rest of their lives." Many children do not have the opportunity to know, much less own a dog. One child was fearful and it was his responsibility to give Beckett her "goodbye" biscuit at the end of the day. He learned to give it to her in a non-threatening manner. They became friends. On the last day after Beckett left, he turned to his teacher and said, "Beckett really loved me. No one has loved me like Beckett."

One of Beckett's Student's teachers writes:

"Beckett was a source of inspiration for three of my students this year. Two of these students were struggling readers, and from an academic standpoint, Beckett was instrumental in their development as readers. ## **Spiders and Wasps and Bees, Oh My!**

Dogs love to explore, but dark secluded places, may present a danger to your pet. Dr. Michael Stone, DVM, board certified by the American College of Veterinary Internal Medicine, Clinical Assistant Professor at Tufts, states that stings from dangerous insects occur predominately on the head and paws. He advises that you should not allow your dog to poke around in dark, secluded spaces, because they may get bitten or stung.

Some of the most common dangers to your dog are from wasps, bees, spiders, scorpions and even some toads. Some general symptoms and treatment are listed, **but you should always seek the advice of your veterinarian. Some of these encounters may be life threatening.**

### **Brown Recluse Spiders**

These spiders can be just a half an inch long with a fiddle-shaped mark on its back. There are eleven species of these spiders around the US, although the brown recluse spider does not exist in California.

Recluses have very much benefited from human-altered environments where they are readily found under trash cans, plywood, tarps, rubber tires, in boxes, etc. They are synanthropic (found in association with humans) and therefore are considered a "house" spider.

**Problems Caused:** The wound enlarges and there is a systemic reaction within 24-36 hours characterized by restlessness, fever, chills, nausea, weakness, and joint pain. Where the bite occurs there is often tissue death and skin is sloughed off.

**Treatment:** Wound may take several weeks to heal and it is best to visit your veterinarian. (One of my dogs got bitten one time, and the wound did not heal for well over a month.)

### **Wasps & Bees**

**Problems Caused:** You may see redness, swelling and the dog may experience some pain. Some dogs have an allergic reaction.

**Treatment:** Cold compresses can reduce the swelling, but it should be monitored by a veterinarian. **A swarm attack or allergic reaction requires immediate veterinary attention!**

**Black Widow Spider** This is a small one-half inch to one-inch shiny black spider with a red hourglass shape on its abdomen. It is seen anywhere from warm dry climates all the way up to Canada. Their venom can injure or kill a small dog. Symptoms can take two or more hours to surface. Luckily they are shy and usually back away to hide rather than attack.

**Always seek the advice of your veterinarian!**

### **Scorpions**

Not all scorpions present a danger, but the bark scorpion contains a toxin that affects the nervous system. **Problems Caused:** Signs that may begin an hour after being stung are, muscle tremors, drooling, breathing problems and frequent urination and defecation. The reaction varies with the size of the animal.

**Treatment:** The stinger can be removed and your vet may suggest medication to control tremors or seizures, should they occur.

### **Toads**

The Bufo toad is usually six to nine inches in length, brown to a grayish brown with a creamy yellow belly. Two species, Bufo alvaraius, common in the South-western deserts and Bufo mainus, that lives along the Gulf Coast and Hawaii can cause particular trouble to dogs.

The Bufo toad is found commonly in Florida, Colorado, Arizona, Texas and Hawaii. They secrete mucus through their skin that can cause intoxication if the dog puts its mouth on the frog, and it can be fatal.

**Problems Caused:** Drooling, vomiting, head shaking, heart rhythm disorders may occur. This may happen 15 minutes after the dog places its mouth on the mucus that this toad excretes, and death could occur in 30 minutes.

**Treatment:** Immediately rinse the dog's mouth thoroughly with cold water, making sure that you do not point the hose directly down the dog's throat. Rush the dog to the veterinarian, so he can be monitored and treated for any heart rhythm abnormalities.

Keep a sharp eye on your Kerries as they explore. Danger can lurk anywhere.

We can change that. We ask you, the leaders of our Member Clubs, to enthusiastically support the AKC Registration Pledge, which states:

**"As a responsible owner of purebred dogs, I pledge: I will encourage, assist, and follow up with my puppy buyers to ensure that 100% of the puppies I produce are AKC registered."**

To introduce the Pledge to your club members, we invite you to participate in the AKC Registration Pledge Challenge, a contest for AKC Member Clubs. Accept the AKC Registration Pledge Challenge on behalf of your Member Club.

### Excerpt from the June 09 Delegates Meeting:

Ms. Van Sicklen: I would like to introduce the AKC

Registration Pledge Challenge. This is a pilot program for Member Clubs and it calls on you, the leadership of AKC Member Clubs, to issue a call to action to your members. Member Clubs include many of our most involved, best informed, and most influential fanciers. We ask every member of every Member Club to take a pledge:

**"As a responsible owner of purebred dogs, I pledge: I will encourage, assist and follow up with my puppy buyers to ensure that 100% of the puppies I produce are AKC registered."**

It's simple, it's direct, and it's achievable. We hope that your club members will embrace the Pledge and rally to this call to action. Because dog people enjoy competition, we've added a contest. In Round 1, Member Clubs with the highest percentage of members who sign the Pledge will be honored at the December Delegate Meeting.

In Round 2, Member Clubs with the highest percentage of dog registrations, either full or limited, from among litters born June 1 through December 31 will be honored and awarded \$1,000 at the June 2010 Delegate Meeting.

We are relying on you to make this work by using your club's communication channels to take the Pledge to your members. Shortly after this meeting, we will launch emails to presidents, vice presidents, corresponding secretaries and delegates of Member Clubs with a web link to go online and accept the Registration Pledge Challenge on behalf of your Member Club. Club opt-in will be available through July 31. As part of the club opt-in process, you will need to provide the number of individual members of your club. This is individual members, not households.

When the club is signed up, your next step is to encourage every club member to go online and individually accept the Pledge. The online Pledge will be available to your members on August 1st. To assist you in communicating the call to action, there are links to a flyer and to newsletter inserts that you can use to promote the Registration Pledge Challenge among your members.

Starting August 1, your individual club members can go online to take the Pledge.

We hope most people will take the Pledge online because that is more efficient and cost effective for us to administer. But if any of your members do not have Internet access, there will be downloadable paper Pledge forms that they can send in.

Your members have until November 30 to take the Pledge. This allows time for your club to promote the Pledge through your newsletter, web site, email groups, and other club communication channels. And the message should be two-fold: encourage your members to sign the Pledge and to make sure all puppies become registered.

You may hear the question, "Why should I take the Pledge if I'm not actively breeding dogs?" The answer is, as members of Member Clubs, we are the "dog people" in our communities. We need everyone to carry forward a message about the importance of AKC registration and responsible dog care. The contest will include four competition categories. Please remember that this pilot program is for Member Clubs. Awards will be available to large Parent Clubs, small Parent Clubs, large Member Clubs other than Parent Clubs, and small Member Clubs other than Parent Clubs.

At the December Delegate Meeting, the clubs with the highest percentage of members who accepted the Pledge in Round 1 will be honored and presented certificates. So to recap, in Round 1 a club officer or delegate goes online to opt-in on behalf of the club, and then starting August 1, your club members can go online and take the Pledge. In Round 2, we will track

the percentage of registrations completed by your club members who took the Pledge. We will look at litters born between June 1 and December 31 of this year. Your members will have until April 30, 2010 to get the dog registrations completed. The Round 2 winning clubs will be those clubs with the highest based percentage of dog registrations. The winning clubs will receive \$1,000. The reserve winning clubs will receive \$250.

Based on the participation and response to this pilot program, we may then extend the Registration Pledge Challenge to licensed clubs and other AKC fanciers.

And please remember, the contest is the fun part. The focus of this pilot program is education and outreach, and to keep this goal top of mind: to get every eligible puppy AKC registered.

## Gromit the Kerry Hearing Dog

Back in the dark ages, I used to show Collies and loved going to shows and watching all breeds whenever I had the time. Kept seeing a few of these beautiful blue dogs and tried to talk several of my friends into getting one just so I could get to know it. They firmly declined. The time finally came, after a whole passel of other breeds, when I finally got around to a Kerry.

We got Gromit, (aka Ardara Gromit - Ch. Kallehan's Truth or Dare x Ch. Ardara's Anything Goes), from Carolee Nicholls at the ripe old age of 10 weeks. We already had a 6 year old Akita bitch, Tako, and I did a lot of research on how the two breeds might get along. It sounded like it would work, with a few cautions, but that is true of any two dogs. I was right. They are good buddies.

I have always felt that having a very smart animal was a mistake. They can dream up all kinds of mischief. Tako was that smart animal. The worst thing she did was eat the couch out of our motor home, leaving us to finish a trip in piles of shredded foam. Gromit is every bit as smart but so far, not nearly as destructive.

I have been deaf for almost 20 years now due to M.S. and am very lucky not to have any other residual effects. Having a retired husband has been a big help, but I still missed doorbells, phones - and the like, all because he refused to spend 24/7 staying home waiting for MY phone to ring.

About two years ago, we learned that friends of ours have a daughter who was training service dogs in N. Carolina, but she was going to be here in town for the summer. She also has M.S., and her mom had told her about Gromit. She knows terriers and thought that, with training, Gromit could be of great help to me. She was right.

Before agreeing to put the effort into his training, she evaluated him. How reactive was he to sound? Did he notice noises? I had to laugh at that one.

This is a Kerry after all. She brought some sort of ringer with her. Every time she rang it, Gromit would come investigate the sound, and she would give him a treat. This was a great game, and he didn't want to quit.

The first thing she tackled in his formal training was a kitchen timer. I hadn't used one of those for years and had forgotten how useful they were. She started out by distracting him and then sneaking a treat by the timer and then setting it. When it went off, she ran to the timer all excited, and Gromit came along. He soon figured out that there was a treat waiting, so it didn't take long for him to catch on to this fun new game. The next step was to get him to come back to her and alert her. After he got his treat by the timer, she would call him and get him to jump on her for another treat. This, we decided, would be his method of alerting me, as I don't always hear him bark. The trick now is to discourage him from jumping on other people. I was astounded to see him trained to jump up at the kitchen counter to get a treat, but he has never taken any food that he wasn't supposed to. I know that it isn't my training that caused all this. How did these Kerries get so smart?

She worked with him from different areas in the house, so he would realize that where ever she (or I) was, that was the place he should go to. After he had caught on a little, I got involved in the training, and he learned to alert me and not the trainer (mostly). Using the same step by step techniques, she trained him to alert me to the phone and the doorbell. The door has been the hardest thing for him. It is so exciting to have someone come to visit, and he just knows that it is someone whose life's ambition is to be covered with Kerry kisses. I still have to encourage him to take time out from his barking and alert me. We are working on getting him to lay down about 4 feet from the door and stay until the door is closed again and he is released. Then, we go get a treat. This works great, unless it is one of his good friends and then he still breaks some of the time. One other thing that he will do is, "Go find Julie." My husband will use this when he

comes in, because I usually don't hear him. That way, I know it is him in the house, and he knows where I am.

Of course, all of this has helped put me back in touch with the world. I can relax knowing that I don't have to worry so much about missing an important phone call. The Akita has to be kept quiet in her crate for an hour after every feeding because of bloating problems, and Gromit will let me know when it is time to let her out. Best of all, Gromit has a job and thinks he is pretty special. He is.

All of the things that he does are inside the house. The trainer felt that he was too distractible to work well on the street. I think in time, when he gets bored with being outside, maybe we could start with some things like sirens; but for now, I couldn't ask for anything better.

To register a service dog in California is fairly painless. I know that there are several groups that train dogs and have tests for them to qualify for whatever kind of service they perform, and the laws are probably different in other parts of the country. In California, all I needed to do was to take a note from my doctor to our local animal services office where licenses are issued. The doctor said something to the effect that I was deaf and needed a dog. They gave me a special California Service Dog tag that will get us in anywhere. I did buy Gromit a red vest that says "Hearing Dog" on it, just to save on hassles. He gets very excited about wearing it and looks very proud of himself.

The really neat thing about all this for Gromit is that it is a great game with food involved. I don't know if he realizes how much of a help he is to me, but then these Kerriess are really cunning little beasts, and I think he probably knows a lot more than I give him credit for.

keep the mouth wet so the panting is more effective. Do not worry about dehydration until the temp has started down. A dog panting heavily taking in large amounts of water is at risk of bloat. Due to the heavy panting they will swallow air, mixed with a large amount of water they can bloat. Once the temp is going down and panting has slowed to more normal panting then allow water. The dog will rehydrate it self after temp is normal. If the dog has a serious some medication. Also, a case of heat stroke can induce a case of hemorrhagic gastroenteritis (not parvo), with a ton of very bloody diarrhea and a lot of fluid and electrolyte loss. These cases need aggressive treatment.

The best method of treatment is prevention. Learn to watch your dog, and see the changes in the size of the tongue, and how quickly it goes down. Learn your dogs response to the different environments, and be careful when you head south for an early season hunt test or trial. I have been to Nashville at the end of May, only 5 hours away, but the difference in temp and humidity did affect the dogs as they were used to more spring weather in Ohio. Try different things in training to help the dog cool and learn what works better.

**Another very important point!**

Do not swim your hot dog to cool it, then put in put in a box/tight crate. Remember, evaporation can not take place in a tight space, and the box will turn into a sauna, and you will cook your dog. Let the dog cool and dry before putting it in their crate.

I know this is a bit long, but hopefully this is easy to understand and helps provide some useful information.

**Remember: Prevention . . . learn your dog. It is worth the time and effort.**

## RESCUE UPDATE!



## Terriers in the Mix

*(The following article, written by Lisa Frankland, was first published on the USKBTC elist.)*

Can Two or More Terriers of the Same Sex Live Together? This was a very hotly debated thread that was on a terrier list several years ago. A woman had "rescued" two terrier bitches of different breeds, both with a known history of dog-aggression, and was now having problems with fighting and marking behaviors in her home, (she was actually more concerned about the latter). The debate on the list concerned whether two terriers of the same sex could get along. Some of the more notable points that came up:

1. The listmembers most likely to say that this could be done were inexperienced and often first-time terrier owners, many whom would cite their own experience with dogs they had in some cases only owned for a few months. Others would heartily endorse it, even while saying, "except for that one time..." or "as long as I don't..." about their own dogs.

2. Listmembers most likely to say, "It's not worth the risk," were long-time breeders and rescue volunteers. The more experience they had, the more emphatic their answers were. While they knew of many terriers who got along together with few or no problems, but they also knew from personal experience what could happen when they didn't.

3. A number of people said that while they would never consider keeping two males together, two bitches would most likely be okay. A number of other listmembers then replied with hair-raising stories of bitches that couldn't get along, bringing to mind the saying about while two dogs are more likely to fight, two bitches are more likely to seriously injure or kill one another should they get into it.

4. The breeders, rescue volunteers, and other experienced terrier people on the list, who did keep multiple dogs successfully, used crates, baby gates, separate rooms, etc., to keep dogs apart, especially during feeding time and when they couldn't be supervised. They had a good understanding of dog psychology and knew what trouble signs to look for as well as what kind of situations to avoid. Even then, they admitted that some fights would still occur. The more typical pet owners and the ones that experienced the worst problems tended to be of the opinion that all the dogs should be one big

happy family, (i.e. love will conquer all), that obedience training is unnatural, and that crates and gates are not only ugly, but cruel!

5. The more experienced people on the list also noted that the chances of fights occurring tended to increase exponentially with the number of dogs in the household.

Incidentally, the woman with the two terriers, who originally started this discussion, did eventually lose one of those "girrrls" in a fight with the other! As another listmember had warned her, to rescue a dog and put it in harm's way is not a rescue. :( Of course, at that moment, my instructor brought over her intact male irish setter and my kerry, Jessie, started licking his face! They said, "Well, your dog isn't aggressive." I told them that this particular dog was his best friend and that despite all my training he could be VERY aggressive.

Lav used to have some male terrier buddies we hung out with at the shows too. We shared hotel rooms with Diane Lee and Wheeler (who was intact) several times with no problems, and I still remember people remarking about Lav and a male "IT" curled up together behind our folding chairs, snoring, while his owner and I watched the terrier group at GWTA. (I have the picture to prove it.) I also fostered several male Kerries with no problems--though they would often play so rough with Lav that I had concerned neighbors call more than once thinking there was a fight! But were they ever left together unsupervised? Were they ever fed together? Were they ever allowed to be or continue in a situation that might lead to a fight? No, no, and NO! My own experience with terrier bitches, however, has been less positive, (Is it just me, or are the girls that much harder to read?), leading me to support the conclusion of point #3, that neither situation is desirable.

They then asked about off-leash and were totally stunned when I said I NEVER trusted my kerry off leash. They didn't seem to believe me that with all the training (they'd just seen me compete in utility, mind you) that I couldn't have him off leash.

Lav has a UDX and still isn't trustworthy off-lead. He's 14 now and a little hard of hearing, but never so deaf as when he doesn't want to hear me! Katie, who doesn't even have her CD yet, is actually much more reliable, but I still wouldn't take the chance of having her off-lead except in a controlled environment (such as an obedience or agility ring). The one phrase I hear all the time from people whose dogs have been lost or killed while loose (that

## ***A Word from Charitable Funds...***

As many of you know the US Kerry Blue Charitable Fund was established in 2002. Its purpose was to serve the Kerry Blue Terrier in four important areas:

- 1) **Rescue Fund** – this fund supports grants used to provide Kerry Blue Terrier rescue services.
- 2) **Health and Genetics Fund** - this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier.
- 3) **Education Fund** – the education fund supports education of all those interested in the Kerry Blue Terrier including publications, websites, and seminars.
- 4) **General Fund** – donations to this fund are used to support the work of the other funds through internal grants to those funds. Undesignated gifts will initially be held in this fund.

Since the Fund was established we have worked diligently to build the assets of the Funds while undertaking major support of the PNA Research being done at the University of Missouri. To date we have awarded over \$20,000 in grants to support Health and Genetics, Education, and Rescue. Our current objective is to continue to grow fund assets while undertaking occasional substantial support such as the PNA Grant. We believe the real key to long term growth will be planned giving that includes the Funds in the wills of our members. Other comparable organizations have used this method as the key to growing their assets. The reality is that we must grow our financial resources substantially in order to having a meaningful impact and that means it will take many years to be in a position to have a significant impact on our core areas.

- ♦ CHIC Goals, CHIC Benefits, CHIC Policies and Guidelines, CHIC Numbers and CHIC Reports, CHIC Fee Structure, Participation, and Contacts.
- ♦ "CHIC Frequently Asked Questions" gives you all of the information you need to know about using CHIC, now that the USKBTC is a member.
- ♦ CHIC DNA Repository contains Frequently Asked Questions, a Mission Statement, Objectives, How to Participate, How to Submit Samples, and a CHIC DNA Repository Health Survey to accompany DNA samples.

Joining CHIC is a timely decision for the USKBTC, and can only benefit our Kerries. It can help us maintain good health along with temperament and type. Participation in CHIC can show prospective buyers that our members care about the health of our dogs, and separates us from backyard breeders and puppy mills. 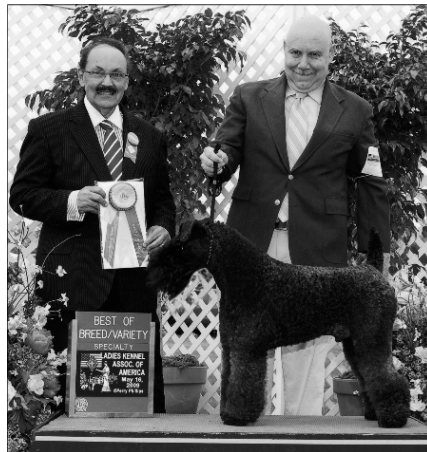

includes loose in an unfenced yard or on a walk without a leash) is, "He never did that before!" Sad what some people are willing to bet their dogs' lives on.

Even though I think they would be a great family for a kerry, I told them I didn't think their situation was right at the time, with all their other dogs. You gave the exact same answer I would have, and have, in similar situations with rescue and breeder referral.

In one case I had a woman call during Westminster week, (the worst time of the year when I was still doing referrals), who was interested in the breed. I actually liked her a lot--she asked good questions and came off as a very responsible and experienced dog person. Problem was, she already had three other dogs, including a terrier mix and a Rottie! I told her that I thought a Kerry would be great with her, but not until she got her numbers down.

I always urge potential owners who already have another

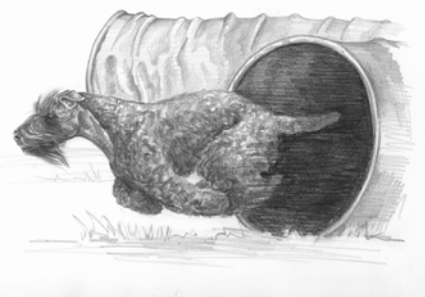

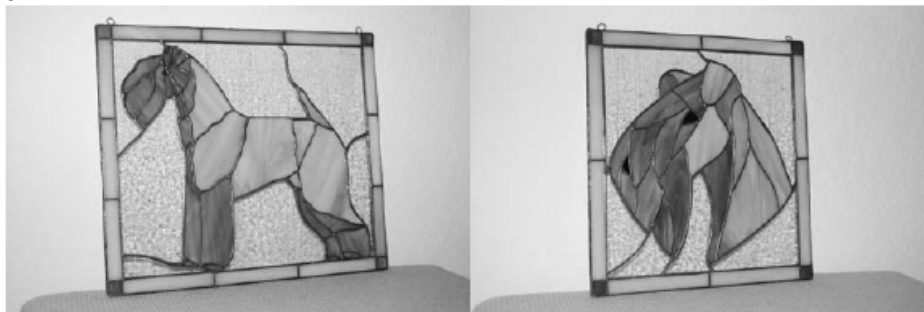

## **Training the Kerry Blue Puppy**

by Carol Postley

The fastest and kindest way to house train a puppy is with the use of a wire crate. The crate becomes the puppy's safe and comfortable bed, and most puppies will make an effort to keep their bed clean. If the puppy is not accustomed to a crate, there may be a couple of difficult days at first, so line the crate with newspaper and shred more paper on top. The shredded paper will help keep the puppy clean in case of accidents. The crate is a home, not to be used as punishment!

In nature no young puppy is ever left alone in a strange place, and the puppy that screams the longest and the loudest in that situation is the one that is most likely to be found by his pack and will survive. So, if you take a new puppy home and leave him alone overnight, you can expect that he will be awake all night and make a real mess of the area. If you take that same puppy and let him sleep in a crate beside your bed, he will feel safe and secure with his new pack leader (that's you) and sleeps through the night clean and quiet. Give him a raw hide toy to chew on, put him in the crate and go to bed yourself. Do not talk to the puppy or fuss over him. Most will quickly fall asleep. If he really persists in being restless, or wakes you up at night, take him out for a quick airing, but that is really unusual. First thing in the morning, pick the puppy up and carry him outside to the place you want him to use to relieve himself. With this method most puppies are clean and quiet through the night from the beginning. After the puppy is settled in and beginning to understand house training, you can move the crate somewhere else.

First thing in the morning or after a meal, take the puppy outside. Give him plenty of time to empty out, and just as he finishes relieving himself really give him a lot of praise. Applaud; cheer, rah, rah, what a clever puppy! This is how you explain to a dog that, yes; this is the place I want you to use. This is your positive reinforcement for correct behavior. Then ask, "are you ready to go in?" and occasionally a dog may, in effect, say wait a minute, and make one more puddle. When you take the puppy indoors, and you are pretty sure he is empty, you may allow him to run free in the room with you, or keep him with you on a lead as you work around the house.

The puppy will play and explore for a while and then settle down to chew on a toy or to nap. When the puppy wakes up or becomes restless, take him out again immediately. Puppies have a very limited capacity for waiting. Each time you prevent a mistake by getting the puppy out at the right time and each time the puppy eliminates outdoors, you are reinforcing the correct behavior and the puppy's natural instinct to keep his home clean. The time will come when the puppy relieves himself and looks to you expecting praise, proof that the puppy is beginning to understand where the "correct place" is. Until this happens you should never, never, make any correction for mistakes indoors. Just clean up and say nothing. If you

make too tough a correction before the puppy understands what is wanted, he may be frightened and simply never do anything when you are nearby. This is what has happened to most older dogs that are not house-trained. Even when the puppy is obviously getting the idea and being clean most of the time, you should be careful to avoid overdoing the corrections. You should see progress each week even though there might be a few mistakes along the way.

If someone is home most of the time and really paying attention to the puppy, he should be well trained in a month. If no one is home during the day, you will be lucky to have the puppy trained by six months of age simply because the puppy is not physically capable of waiting that many hours. Can you wait all day? It will speed up the process immensely if you can get someone to take the puppy out in the middle of the day. Just keeping a puppy outdoors doesn't help because he is not learning to wait and to keep certain areas clean.

When you are too busy to pay attention to the puppy, when you have to leave the house for a while, exercise the puppy and then put him in the crate and go about your business. Ignore the puppy. He should be used to spending some time in the crate every day.

Kerries have a wonderful barometer on their rear ends, the tail! If you catch the fellow chewing on a chair leg and you tell him "no", and the tail stays up and he goes right back to chewing, you know that that correction was not severe enough for that dog. If on the other hand the tail goes down and stays down, you over-did it a bit. Should a dog pick up a piece of laundry you dropped, a mild "no" would probably be appropriate. Don't use the same correction for minor things that you would use for something major.

If you crate the puppy when you are too busy to keep an eye on him, the puppy will not be learning -destructive habits, and prevention is much more effective than corrections. As the puppy becomes more civilized, you may gradually increase the time he is left unsupervised. At the first sign of chewing or soiling, go back a few steps and use the crate. Almost all pet owners give the puppy too much freedom too soon, which fosters the formation of difficult habits. It is not uncommon for a puppy that seems well trained to go through another chewing stage as an adolescent. Just use the crate and closer supervision again. Dog breeders often house-train several new puppies each year, and with the help of a crate, their houses survive with less damage than most pet owners have with one puppy.

The surest way to bond a puppy to one person, if he is supposed to be Suzy's dog for instance, would be for him to sleep beside Suzy's bed and for her to begin basic obedience training the day after the puppy arrives.

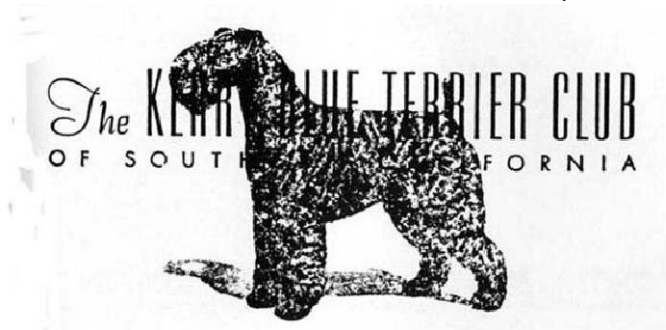

**De-Skunking**

Loss of habitat is forcing more and more wildlife into populated areas, so even if you are a city dweller, your dog may encounter a skunk. There are several products on the market made specifically for removing skunk spray. Two such products are "Nature's Miracle Skunk Odor Remover" by Nature's Miracle, and "Skunk Off" by Thornwell Corporation.

Some suggestions for bathing a dog who has skunk odor:

Before handling your dog, you may want to change your clothes. Skunk spray is very difficult to remove from clothing. Cover the dog's bed with something to protect it. Leaving the dog outdoors for a while will greatly reduce the odor.

Determine where the spray hit the dog. Depending on your dog's hair type, you may be able to trim away or comb out some of the affected hair.

When you're ready to wash the dog, only clean the sprayed area. Skunk spray is oily and can easily be spread all over the dog. Since you will likely have to repeat the procedure, save an all-over bath until the second or third washing.

**Editor's Note:**

In a recent article (December 2003) of "Your Dog" newsletter published by Tufts University School of Veterinary Medicine, they suggested a safe home treatment for de-skunking your dog.

Wash the dog with the following mixture:  
One-fourth of a cup of baking soda  
One teaspoon of liquid soap  
One quart of hydrogen peroxide

*Blueprints Editor's Note: I have personally used the mixture recommended by Tufts University School of Veterinary Medicine on one of our girls, and can report that it worked well for us.*

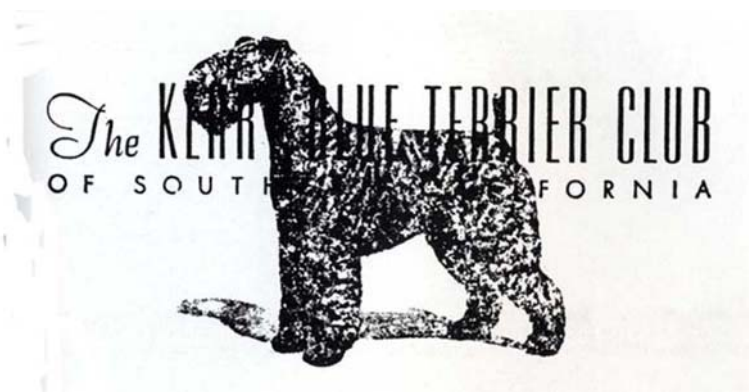

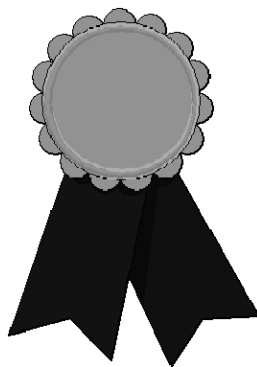

3. You will be promptly notified, in writing, of the Board's action.
4. You will be provided with a copy of the approved Constitution and Bylaws.

This Membership process can take up to six (6) months or more, due to the publication of BLUEPRINTS<sup>SM</sup> three times per year, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership, your application fee will be refunded.

**THE UNITED STATES KERRY BLUE TERRIER CLUB  
CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

**I. RESPONSIBILITIES AS A MEMBER**

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

## II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names, and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- **Be prepared to assume lifetime responsibility for any litter produced.**

## III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

## IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
