## Dog Park Etiquette.....for Dogs and Owners!

It is a Saturday morning and I am working with a client with a new puppy. We meet in a park that tends to be low traffic. It is across a main street from another park, that although not an "official" dog park, has been an off-leash area for dogs and owners to gather for the 20+ years I have lived in the South End of Boston. The park has fencing on all 4 sides with open, non-gated entrances on all corners.

Prior to beginning our training, we had a conversation about dog parks in general, and specifically the park across the street. The client is an un-experienced, first-time dog owner who has already had a few unpleasant interactions with other dogs in the park.

As we finish our training session and head across the very busy main street, we are greeted, in the middle, by an exuberant lab mix, sans owner. I immediately coax the dog back to the sidewalk, and then we wait. This is a good lesson for my client.

It takes a full 5 minutes for the dog's owner to realize he does not know where his dog is, then another 2 or 3 to locate the dog. When he sees the dog on the sidewalk, *outside* the park, with me, he *slowly* walks over to see what is going. When I inform him I plucked the dog out of the intersection, he wants to know how far the dog was into the street. Like that makes a difference! The lack of concern was astonishing.

I have seen an increasing amount of bad behavior, by both dogs and owners, to the point where I no longer frequent dog parks. I opt for leashed walks with planned off leash outings.

If the following etiquette rules were followed, there would be a lot less fighting among both dogs and owners:

- ◆ Pay attention to your dog, not your coffee and friends; you should know where your dog is at all times to ensure he does not get out of the park, or worse yet, get stolen
- ◆ Pay attention to your dog's body language as well as that of the other dogs he is playing with; preventing escalation in an iffy situation is the best way to avoid a dog fight
- ◆ Know that **you** are responsible for your dog's behavior, good or bad, as well as his safety; it is not acceptable to allow your dog to:
  - \* Rush other dogs as they enter the park
  - \* Bully the more submissive dogs in the park
  - \* Hump every dog he sees
- ◆ Don't bring your toy possessive/aggressive dog to a park where you know other owners use balls, Frisbees, etc...
- ◆ Don't bring your "can be" dog aggressive dog into the dog park – period
- ◆ And last, but not least, if your dog does get into a scuffle, act responsibly; do not chalk the incident up to "sorry, but it is dog park, and dogs will be dogs"

## Getting Started in Agility!

Agility was originally conceived as a demonstration for the Cruft's Dog Show in 1978. Thirty years later it is the most popular dog sport in America. Maybe you have been thinking you might like to try it too! Even if you never intend to compete it is still important to get a good start in the best class you can find. The good news is that just going to a weekly class and working at home will greatly enhance your relationship with your dog. Working and learning as a team strengthens the bond you have with each other. You will both be proud of yourselves as you learn new skills together.

If you think agility might be for you visit a local agility trial. The Clean Run website [www.cleanrun.com](http://www.cleanrun.com) has an events listing. Your local dog show superintendent may also list some agility trials. You will get a chance to see some dogs and their handlers in action. You may want to talk to some of the handlers and ask who they train with.



Before you start classes evaluate your dog's level of fitness and health. Make sure your teammate is ready to take on the jumping and climbing that is necessary in agility.

Your dog may need to lose some weight before you begin classes. Extra weight will put additional stress on joints and muscles during climbing and jumping. A visit to the vet may be in order. If you are starting a puppy rather than an adult dog you will have some additional concerns. Training exercises will need to be modified for the young dog so as not to injure their growing bodies. If your dog is dog aggressive agility is not the sport for you. It is not fair to your fellow students to put their dogs in jeopardy. Keep in mind that agility is an off-leash sport and you must be able to control your dog.

You will also need some basic training skills. While some beginning classes start with you working your dog on leash you will need to be able to transition fairly quickly to off leash work. For this reason your dog will need a reliable sit or down which can be performed in a distracting situation. You will also need a dependable recall. If these skills are a problem for you start with an Obedience class first. You are not going to enjoy agility without these skills. Check with your local Dog Training Club for a Basic Obedience class.

Finding a class will involve some effort on your part. If you

live in a large metropolitan area you will naturally have more choices. If you live in a smaller community you may have to travel some distance for your weekly class. As a beginner you will need what I call a "Clean Slate" class. Also referred to as a Foundation Class this class is geared to a dog with no previous experience in the sport. Some trainers only offer this type of class once or maybe twice a year. Others form a class when they have a sufficient number of requests to form a class. Because of this you may have to wait for a class to start or you might want to try a private lesson to get started. If you go the private lesson route be aware that going to a group class is very important. Only in a group setting will your dog learn to ignore distractions and focus on you and the job at hand. Your dog's full attention on you is essential for any training to be successful.



A good way to explore the training options in your area is to visit the Clean Run website [www.cleanrun.com](http://www.cleanrun.com). Clicking Events on the main page will take you to a page with a link to Clubs and Training. Follow that link and you will be able to search by state and even town or city. Once you identify some possibilities contact them and see if they offer a foundation class. Many of them will have a website that will tell you what classes they offer and when. Prices may be listed and starting dates also. When you find a likely prospect ask to visit their facility and watch a class given by the instructor who be teaching your class. The equipment and facility should be in good repair. Notice the way the instructor interacts with the handlers and their dogs.

You are looking for an instructor with experience training a variety of different dog breeds. Ideally this person is actively competing with their own dogs and is well versed in current training methods, someone who is flexible and knowledgeable enough to have a variety of ways to solve a training problem. The instructor should be able to keep the class moving and not allow a particular handler to monopolize the class time.

Foundation classes will usually cover jumping skills, exercises to develop basic handling skills, contact work and introduction to the weave poles. By giving your dog a solid founda-

tion in these skills you will greatly improve your chances of smooth sailing down the road. Once you have some experience with these skills you will progress to simple sequencing (two or three obstacles in a straight line or simple pattern).

Sometimes a particular instructor or class is just not a good fit for you. Don't give up do some more research and try again. The main goal at this point is a pleasant introduction to agility for you and your dog with emphasis on good foundation skills.

Once you start a class be sure to do your homework. A few minutes here and there each day will enable you to make progress more easily in class each week. Having a few jumps and a set of six or more weave poles will be most helpful to your home training. Jumps can easily be constructed with pvc pipe and simple fittings. Weave poles can be simple pvc poles with a base suitable to stick in the ground. You will then just need to measure the correct distance between the poles. Jump bars and weave poles should have a colored tape spiraled around them as a visual aid for the dog.

If you are starting a puppy rather than an adult dog the training exercises must be modified so as not to cause injury. Jumping skills can still be taught but with the bars on the ground. Handling skills can be taught using a jump frame without a bar. Weave poles are not started until the dog reaches at least a year of age - longer for larger breeds. One year of age is sufficient for Kerry Blue Terriers.

Take the time to train properly. If you are having trouble with your homework let the instructor know at your next class. Don't measure your progress by the other teams in your class. Every team will progress at their own pace. To train a dog to the level needed to go to a trial takes between a year and a half and two years. Most of all have fun with your dog!

Most people starting their first agility class have no intention of ever competing in a real trial. However if the dog and handler decide they enjoy agility, sooner or later the

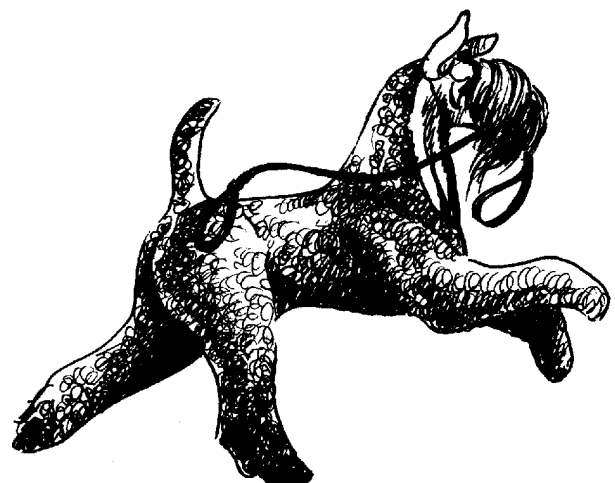
handler is going to give trialing some thought. Let your instructor know what you are considering so that they can help you to evaluate when you might be ready. A good way to give it a try is to find an informal match. Usually called a Fun Run or Fun Match these events are less structured than an actual trial. Entry fees are generally low and you are usually able to purchase between 4 and 6 runs a day. Standard and Jumpers are offered at both the Novice and Advanced level. You will be able to see if going to a trial is for you and what you need to work on before you do.

If you have made it this far you may be wondering how I started. In 1999 I attended an 8 week seminar because I thought agility looked like fun. Beyond that seminar my training was sorely lacking. Over a year later I found out how much I didn't know and the long list of things I was doing wrong. Undaunted and by this time wanting to go to a trial I pressed on and in August of 2000 Riley and I would go to our first trial. April 4th of this year we earned his Master Agility Championship usually called a MACH! He is the third Kerry and the only male to earn this title. The title requires 20 Double Q's which are two perfect runs in one day from the Excellent B class and 750 points earned at the rate of 1 for each second under course time. It was a long road with many lessons to learn but what a thrill to really be a team with your Kerry!



Now go have fun with your dog!

# Herding Instinct

Neatly tucked amidst the rolling foothills of the Blue Ridge in North Carolina, lies Possum Hollow farm. Stock dog trainer, Vickie Hughes her sister Robyn Taylor and assistant trainer Lauren Hohensee welcomed the Western North Carolina Herding Association to its first herding instinct test and AKC fun trials. A veritable smorgasbord of hopeful herders and their people gathered on the sunny June morning to participate.

Edie Brown with "Deacon" (Ch. Lughnasa's Demon Deacon) and "Sister" (Ch. Everglory Elf Loch Southern Sister) and I were happy to see a familiar Kerry face in the form of Allen Comeaux's "Layla" (Ch. Liberty's Princess Diana) fresh upon our arrival. Then Lynn Duckett arrived later in the morning with "Lance" (Ch. Kerigolf's Christmas Knight) to bolster the numbers of the Kerry representation.

The instinct testing is done in what is referred to as a round pen, a limited space wherein the trainer/handler is able to maintain close control over the sheep and dog. At this event each dog was first handled on lead by trainer Lauren Hohensee,. The owner was then allowed to come in the round pen with Lauren and attempt to handle the dog on lead or off lead if the dog was under reasonable control, using a staff if necessary.

Among the other breeds in attendance for instinct testing were a Puli, Old English Sheepdog , a Sheltie, an Australian Shepherd plus a few Border Collies...and two Samoyeds! I believe the funniest moment the entire event was when the first Samoyed was introduced to the sheep. If sheep can convey expression, the looks on their faces spoke wondering curiosity. I believe at first they thought they were greeting kinfolk...that is until the Samoyed got to work. Then I'm pretty sure the sheep decided this was NOT a fellow flock member. Samoyeds were used to herd reindeer and this was obvious in the interest both exhibited in driving sheep.



Because Kerry "Sister" is such a varmint dog I was very nervous about how she would react to sheep, fearful she'd be more interested in rare mutton than moving livestock. But she fooled me completely! On her first run she seemed to very politely follow the sheep around with handler Lauren, looking up at her occasionally for guidance. The sheep did move, but as to aggressively pushing the sheep? Politeness dictated that would be bad form. I was truly surprised as "Sister" has dispatched all

sorts of vermin. On her second run, she showed more interest, but apparently still



believed she shouldn't chase the animals. According to Vicki, "Sister" needs to unlearn a few good manners! She encouraged me to continue with her, citing several dogs (including the Puli present that day) that during a first test seem lukewarm about the sheep, but progress strongly.

"Deacon" was next to make a start and showed quite a bit more interest in the sheep, although completely under control on both his runs. He was amenable to anything Lauren wanted him to do, but being not many months off the specials circuit, he

wondered if this wasn't a dog show. When Lauren would say his name he'd stop, turn to her and stack himself in a show stance! Edie changed his collar over to a buckle type on his second run and this helped with the confusion. While being a gentlemanly type, "Deacon" showed an interest that would likely build quickly with further exposure. The trainer described him as a dog with powerful presence and strength. Those qualities are certainly a plus in stock work.

Next up was "Lance", who very like "Sister", seemed to believe good manners are always in order and demonstrated restraint on his first run, looking to his handler for guidance to make sure he wasn't behaving badly. But he also improved in interest on his second run. It's pretty obvious that sensibility is truly a hallmark of the breed and a well trained one finds it hard to break with civility even when encouraged to do so!

A welcome lunch break at a nearby mom and pop diner allowed all to enjoy a tasty meal and easy camaraderie. These are a great bunch of folks with dogs of varying skill levels in herding, as well as some titled in other disciplines. Mainly, they're people enjoying great times training and working their dogs.

Afternoon saw the AKC match classes begin and we were happily treated to HT and PT performances. We looked forward to watching Allen and "Layla" in HS (Herding Trial Started) and were predictably impressed by her performance. Among the other participants that day

were the surprised and perhaps those a bit skeptical to find Kerry Blues participating. Skepticism changed to admiration shortly after "Layla" and Allen entered the pen. "Layla" worked with impressive precision, only a couple of times succumbing to the excitement by dancing a bit and barking joyfully, but went right back to work after a few stern reminders from Allen. Those doubters were soon believers as this team proved equal to the task. Some just don't know about the Jack of all trades quality in our wonderful breed. They're learning!

Vicki spoke in glowing terms about her experiences in training Allen and "Layla" and is a very positive advocate for our breed in stock work. immediately respond to Kerry Blue Terriers with respect. The trainers feel there is something in the breed's posture and attitude to which this might be attributed. The obvious conclusion is this innate quality is an immediate boon to a successful stock worker.

Once again, there seem to be no limits to the talent and ability of the Kerry Blue Terrier!

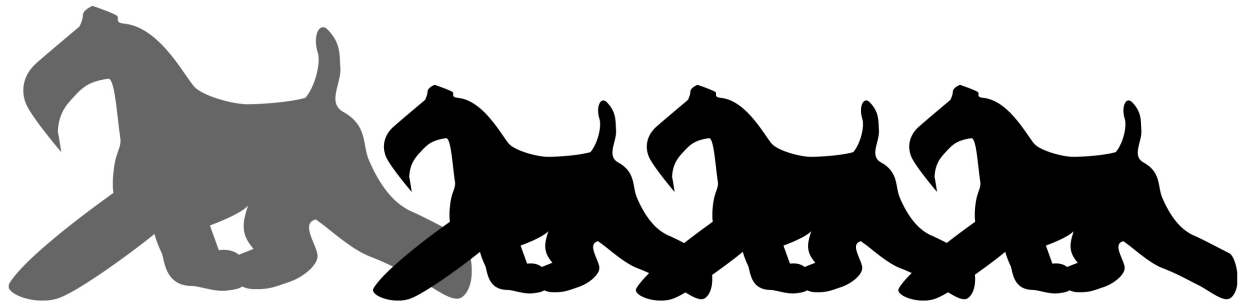

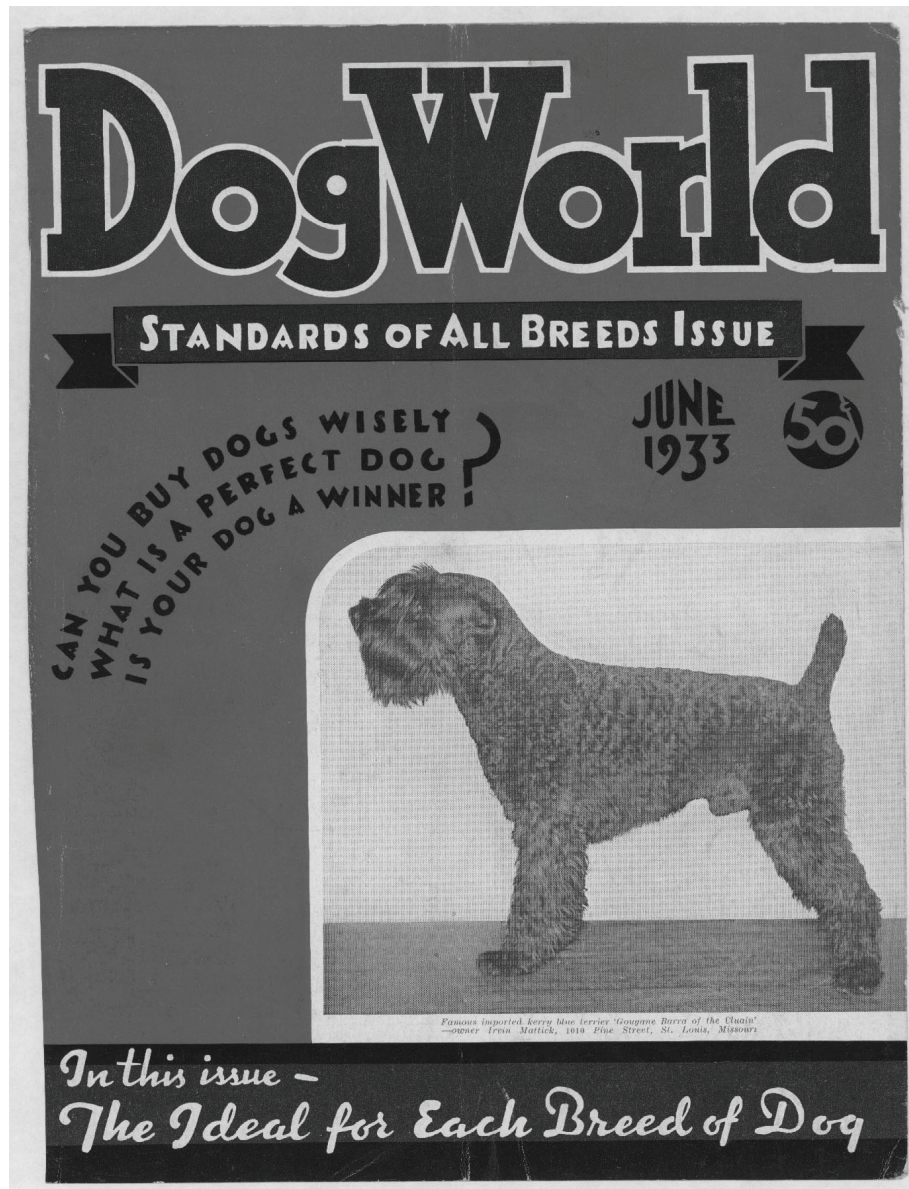

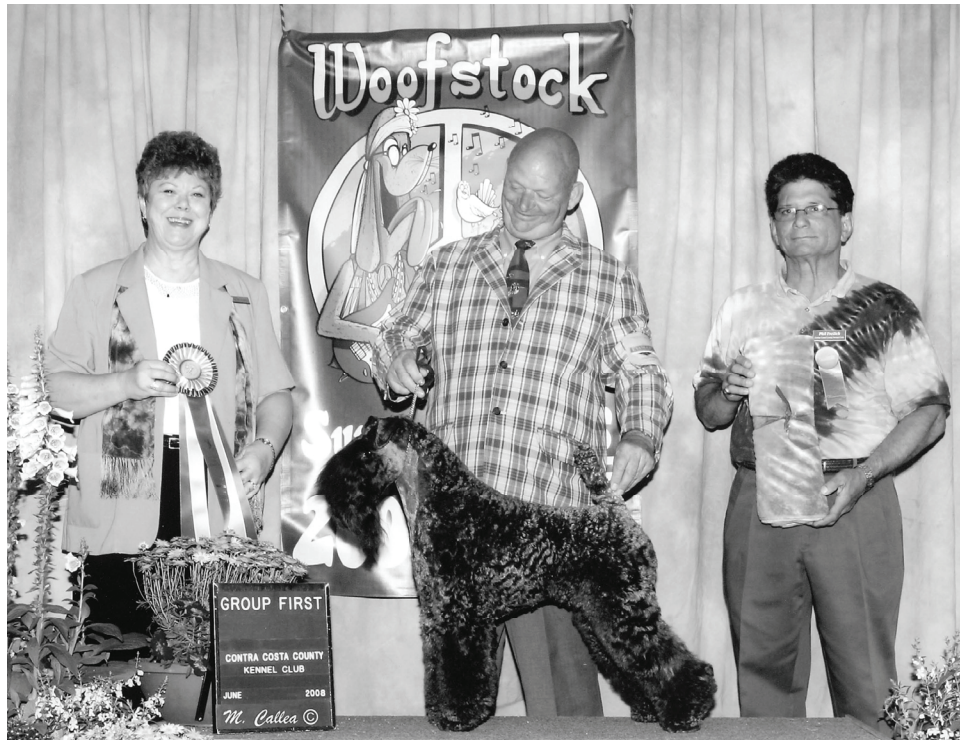

## Rescue News

**Warning: Lack of socialization and training can be fatal!** Several years ago I compiled a list of reasons people give when getting rid of their dogs and found that they could all be classified under at least one of 3 broad headings: lifestyle changes, behavior issues, and mismatches between the owner and the dog. And guess which category is not only the largest, but contains the dogs that are usually the most difficult to successfully re-home? The answer is behavior issues, and the saddest part is that the vast majority of these problems could have been prevented with proper training and socialization.

I recently dealt with 3 cases in less than a month of owners who could not deal with their Kerries' problem behaviors. The first two—a dog and a bitch, both 7 year old rescues—ended up being euthanized because their behavior had been allowed to progress to the point where they were dangerous and could not be safely re-homed. Although the two came from completely different backgrounds—the dog was originally sold by his breeder to a loving family, while the bitch was one of dozens of sick and starving dogs confiscated from their animal collector owner—both suffered from a lack of early training and socialization. The dog was great with people, and got along fine with dogs and other pets that he was carefully introduced to, but would try to attack any dog he didn't know. The bitch, OTOH, was terrified of new situations and people, and to make matters worse, had little or no bite inhibition. Both dogs had responded extremely well to training when they came into rescue, and initially continued to do well in their new homes. Human nature being what it is, when some of the problem behaviors started to resurface, the owners chose to isolate the dogs and make excuses for their behavior. And when they finally did seek advice, it was too little, too late. The male Kerry was euthanized a year after being adopted when he killed a friend's toy poodle in what was described as a vicious and unprovoked attack. The bitch lived with her new family for 6 years until they could no longer deal with the bites that were occurring with increasing frequency and severity. Certainly not the endings myself or any of the other volunteers who were involved in these dogs' rescues and placements ever imagined. Rest in peace at the Rainbow Bridge, Sammy and Ivy.

The third Kerry was a 3 year old male whose owner contacted me for training advice. This first-time owner had gotten the dog from a friend just six months earlier, and was having increasing problems with him behaving aggressively towards other dogs. The training classes he was taking dealt with the dog's behavior by blindfolding and muzzling him, even banning him from attending whenever the rest of the class worked off lead! Needless to say, this was only making the problem worse, and the owner ended up returning the dog to his breeder. This case has a much happier ending because the dog had been well socialized and trained as a youngster, and the problem was addressed early and not allowed to progress to a point of no return. With proper handling, this dog

should be toeing the line in no time at all, and will be able to be re-homed with a dog-savvy family.

If there's a lesson to be learned from these stories, it is to socialize and train your Kerry early and throughout its life. Deal with small problems early before they become big problems, and if you aren't getting results with one method or trainer, find another.

**Rescues:** In March, someone sent the following e-mail to the Club's website:

Comments: We have had a KB, named Blu, since we adopted him from the pound 4 years ago. But we have had a really rough time with him. Blu is sweet but he runs away every chance we get, we can't afford to get him trained, and we feel guilty keeping him in his kennel. We live in a neighborhood where he can't run around and he is so hyper. We can only afford to get Blu groomed once a year. We can send a picture if you want. We don't want to take him back to the pound so we have run ads with no response. The groomer tells us he is a pure Kerry Blue so we know he would be worth a lot to someone. PLEASE help if you can.

Many thanks once again to Gretchen Quinn, for fostering and placing **Guinness**, a nine-month old male puppy. His owners had purchased him from a "nice Amish family" (translation: puppymill), choosing him because he was the shyest one in the litter and they felt sorry for him. The husband told me they were surprised that Guinness hid under their porch when they first got him home! But the real issue appeared several months later after the wife was diagnosed with COPD and they realized they could not deal with a rambunctious adolescent terrier. Gretchen quickly found a home for Guinness with a martial arts instructor that takes him to work everyday. All that mental and physical training is good for dogs too!

Thank you to Sue Gastrock and the "Texas folks," and Conni Adams and the Florida Club for their respective placements of **Rhett** and **Jeri**—both Kerries whose elderly owners had died. I also am deeply grateful to the KBTC of Southern California for their recent fostering and placing of **Molly** and **Paddy**, among others. I started off doing Rescue as a member of the KBTCSC back in 1993, and this Club has continued to be a model for chapter club rescue programs. Thank you all!

**Moving On:** When I agreed to serve as the USKBTC's national rescue coordinator two years ago, it was with the understanding that I would do it for two or three years at the most. No individual is indispensable, and no position should be for life! So come October I plan to step down and let someone with a fresh perspective take over the national position. I will be happy to provide support and advice to my successor, and will continue doing rescue work at the local level, the key word being local!

**Correction:** A key sentence in the new Rescue Policy, concerning breeder responsibility, was not printed correctly in the last edition of Blueprints. The phrase, "after

## *Notes from Health and Genetics...*

### **Congenital vs. Hereditary, Part II**

I would like to share with you my experiences gained from my last litter. One of the pups was very small, tiny in fact, and typical of a premature baby that should have been in the womb for a few more days. Lifting the sac in my hand felt weightless. I was expecting to see a mummified fetus, but to my surprise, was a two-ounce puppy that started breathing. This puppy would not nurse and had gray mucous membranes from the start. I debated on tubing her but after two hours of not nursing, I felt that this little critter needed nourishment. I mixed up my special puppy formula and passed an esophageal gastric tube giving her enough so she had a puffy marshmallow belly. Her body temperature was very low so placed a heating pad and blanket under her. Her respiration was very irregular and she could not get enough oxygen to give her those nice pink mucous membranes; gray was her color. About a half hour later this puppy crossed the Rainbow Bridge.

What would you do as a breeder at this point? I knew of two options:

- 1) Dispose of the puppy (and forget about it).
- 2) Chill the puppy (DO NOT FREEZE) and inquire about a necropsy.

I opted for the necropsy because:

- a) I tube fed this puppy and did it aspirate from my tubing? I never had this happen, however, there's always the first time. Aspiration would be easily determined during the necropsy.
- b) What is the anatomy of this puppy? Was there a defect and why did this puppy fade away?

The next morning I asked one of our veterinary staff to necropsy the puppy. I gave a brief synopsis about my concern on tube feeding and the color of the mucous membranes. Upon necropsy, this puppy had a hole between the two ventricles of the heart. That is my answer as to why this puppy had such poor color and that was the cause of death.... no aspiration into the lungs from my tube feeding. The veterinarian was surprised to hear that it lived as long as it did (three hours) after being born.

The rest of the litter was doing fine. All were gaining except for one little boy. About a month later, "Sullivan" was very small next to his littermates. I had supplemented him and tried to get weight on him. His body seemed somewhat deformed; short little Dachshund legs. He was growing but very slowly as compared to the others. In the back of my mind, I questioned if I should keep him going.

I approached the veterinary staff again and asked questions about dwarfism and what they thought could be happening. The same doctor who performed the necropsy came forth and requested that she auscultate his chest and diagnosed that he had a heart murmur. The next step was an ultrasound and a ventricular septal defect was found. So now I had two puppies out of a litter of six that had heart defects.

I have consulted with various veterinarians and cardiologists who all agreed to let this puppy mature and let it live its life doing nothing to repair the defect. One human cardiologist remarked that he sees children with much larger septums and no surgery is ever performed on them for repair. "Sullivan" is now over a year old, enjoying his family, and living as a normal happy Kerry Blue Terrier.

The moral of this story – The keynote was the necropsy findings on the dead puppy. It is important to know why fading puppies die. This also helped explain the heart murmur in the littermate.

Now I ask is it congenital or hereditary??

If any of you have owned or experienced a Kerry Blue Terrier with a heart murmur/defect, please share with me. Thank you for your interests.

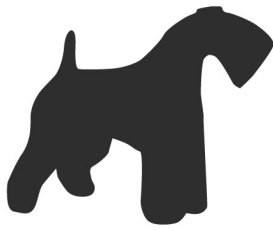

1. A notice of your application will be published in the next issue of the official Club publication, BLUEPRINTS<sup>SM</sup>.
2. Thirty (30) days after publication in BLUEPRINTS<sup>SM</sup>, your application and any members comments will be submitted to the Board of Governors for consideration.
3. You will be promptly notified, in writing, of the Board's action.
4. You will be provided with a copy of the approved Constitution and Bylaws.

This Membership process can take up to six (6) months or more, due to the publication of BLUEPRINTS<sup>SM</sup> three times per year, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership, your application fee will be refunded.

**THE UNITED STATES KERRY BLUE TERRIER CLUB  
CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

**I. RESPONSIBILITIES AS A MEMBER**

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

## II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names, and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- **Be prepared to assume lifetime responsibility for any litter produced.**

## III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

## IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
